CHARGING RULES



- The billing period is from the 15th to the 14th of the subsequent month.
- The Adhesion amount is charged upon activation of the Service.
- B3 will collect the remuneration for the current month up to the fifth business day of the subsequent month, which shall always be settled on the third Monday of the following month, unless otherwise provided by B3. In the first payment, the pro rata amount will be calculated between the Effective Date and the last day of the first month in force.
- Way of sending the bill: bank invoice and invoice (for non-residents in Brazil).
- Expiration: According to the Service contracted.
- Default: fine and interest as stipulated in the Service contract.
- Updating of values: According to the IPCA index, applied in the month of January of each year. or according to the Service contract.
