# CIRCULAR LETTER

## Re.: New Trading Hours – Rollovers and FRP1

We hereby inform you that as of **April 17, 2024**, Ibovespa Futures Rollovers (IR1) and Mini Ibovespa Futures Rollovers (WI1), US Dollar Futures Rollovers (DR1), Mini US Dollar Futures Rollovers (WD1) and Forward Points on US Dollar Futures structured transactions for positions generated on T+1 (FRP1) will be traded **until 6:30 p.m**.

Furthermore, with the start of trading of the Bitcoin Futures Contract as of April 17, 2024, we inform you that the timetable for Bitcoin Futures Contract (BIT) trading and for the Bitcoin Futures Rollover (BT1) structured transaction will be **from 9:00 a.m. to 6:30 p.m**.

These updates to the derivatives market timetable are contained in Annex I hereto. Please note that there will be no change to the trading hours of the other derivatives market contracts that have not been specified herein, nor to the equities market trading times or to the equity option exercise procedures set out in Annexes II and III.
