CIRCULAR LETTER

To: B3's Market Participants – BM&FBOVESPA Segment

Re: Change to Activity Parameters for Market Makers in Put Options on PETR4 and VALE3, and Options on BRKM5, EMBR3, EQTL3, HYPE3, LAME4, MULT3, RADL3, RAIL3, SUZB3, BBDC3, BBSE3, BRAP4, BOVA11, CSNA3, CYRE3, ELET6, ESTC3, GGBR4, KROT3 and PCAR4.

We hereby inform you of a change to the activity parameters (specifically the activity period and mandatory expirations) for the Market Maker Program announced in Circular Letter 008/2019-VPC, dated May 30, 2019.

Market makers are required to trade for at least ten (10) minutes in the last thirty (30) minutes of each trading session. They are also required to register bids and asks until the fifth business day before the expiration dates for the first monthly contract and first quarterly contract available for trading. As of the fourth business day before these dates, they are not obliged to trade in the first monthly and first quarterly, but must trade in the subsequent contract months admitted to trading.

Thus the obligations of market makers are now as follows:
