This document describes the series of tests that qualify a third-party institution to connect to B3 for the purpose of routing orders for Derivatives and Equities segments using FIX4.4 (Financial Information exchange).

FIX is a technical specification for an electronic communication of trade-related messages. It is an open standard managed by members of FIX Protocol Limited. (www.fixprotocol.org)

This document outlines the certification process to route orders through B3 EntryPoint and is provided for third-parties which need trading connectivity with B3.
