Re.: Open Interest Limits per Market – Reallocation of Position Limits among Markets – MRFG3 (MARFRIG ON) and RRRP3 (3R PETROLEUM ON)

We hereby inform you that as of **April 19, 2023**, the position limits in the markets for listed options, forwards, futures, securities lending (BTB) and flexible equity options with MRFG3 (MARFRIG ON) and RRRP3 (3R PETROLEUM ON) as their underlying asset will be reallocated, with the limits described in the table below into effect.
