CIRCULAR LETTER

To: B3's Market Participants - BM&FBOVESPA Segment

Re: New Trading Hours – BM&F and BOVESPA Segments.

B3 hereby informs you that due to the end of daylight saving time in Brazil on February 18, 2018 and the start of daylight saving time in the U.S. on March 11, 2018, as of **February 19, 2018** it will change the trading hours of its exchange and organized OTC markets, in accordance with the three separate time grids set out in the following Annexes to this Circular Letter:

- Annex I Time grid effective from February 19, 2018 to March 09, 2018 for the BM&F Segment (Commodity Futures, Options and Structured Transactions);
- Annex II Time grid effective as of March 12, 2018 for the BM&F Segment (Commodity Futures, Options and Structured Transactions); and
- Annex III Time grid effective as of March 12, 2018 for the segments:
 - BM&F (Equity Index Futures and Options and Structured Transactions;
 and U.S. Dollar Futures, Options and Structured Transactions); and
 - BOVESPA.

Please note that the trading hours effective for the Forward Points on U.S. Dollar Futures Contract for the T0 open positions (FUT FRP0) will remain unchanged.



Please also note that as of **March 12, 2018**, the Price Report (BVBG.086) and Index Report (BVBG.087) files will be published according to the estimated times described in the table below.
