#### **1 PRODUCT DESCRIPTION WITHIN THE DATAWISE SERVICE**

The DATAWISE product was created by B3 with the aim of helping its clients in strategic decisions consolidating various reliable and/or sensitive data in the form of interactive dashboards (DATAWISE Dashboard) and reports (DATAWISE Reports). It should be noted that as stated in the Commercial Policy, the DATAWISE service does not allow the distribution or redistribution of data.

Each of these modules can be contracted separately as well as their products (individual dashboards and reports), according to the client's intention. Through the interactive panels it's possible analyze the behavior of stocks (BOVESPA), derivatives and stock futures (BMF) and rental of stocks (BTB) with DATAWISE Dashboards. Already in DATAWISE Reports you can analyze trading and post-trade asset data, mainly from the OTC market thought reports with raw data (Data Report) or worked reports (Market Report).

In this manual we will show the Stock Ranking dashboard layout, data and filters contained in the DATAWISE Dashboard module.

#### 2 DESCRIÇÃO RANKING DE ESTOQUE

The Stock Ranking shows the entire financial volume held in custody by participants at B3 and the open interest contracts to be settled. In the BMF segment, only the OZ1 asset (Gold) is available for custody query while the other assets in this segment are placed in open interest contracts.

The Custody dashboard is divided into three panels, while the open interest has four panels. These panels allow you to monitor the presence of each brokerage house and their evolution from one period to another. Data can be filtered by commodity, instrument, ticker, asset and investor category. This dashboard allows you to view the Custody evolution at B3 and analyze which are the most relevant brokerage houses by commodity, instrument and market.

#### **3 STOCK BMF AND BOVESPA – CUSTODY**

The dashboards of the listed segment (BOVESPA) and Derivatives and Futures (BTB) have custody information divided as follows:

#### 3.1 Consolidate

In this panel, it is possible to access the information on this dashboard in a compiled manner such as:

• An overview of ranking by greater financial volume in custody at a granular level, being by position date and ticker;

• The ranking of participants' positions by custody balance or number of contracts;

• The ability to view the distribution of custody by financial value or number of contracts - based on investor category, participant or custody asset.

In this panel, it is possible to access the information on this dashboard in a compiled manner such as:

• An overview of ranking of Open positions, at the level of granularity being, by position date, ticker, financial value and number of shares.

• Visualization of the distribution of the open position, by financial value or number of contracts - based on the category of investor, participants or instrument.

**Ticker** – Allows you to choose the ticker of the instrument to be assessed. All assets traded on the analysis date will be available. Only one ticker is allowed to be chosen at a time or view the entire market when removing the filter.

**Metrics** – Financial Volume and Stock Quantity are the metrics available for viewing the dashboard.

For Derivatives and Futures (former BM&F segment) use the number of contracts

for a more assertive analysis.

**Investor Category** – The different investor types are in the same colors as the other dashboards and have their percentages distributed according to the trading volume and chosen filters. It is possible to select investor categories as a filter from one click. By clicking and **holding down the Ctrl key**, you can select more than one audience at the same time.

**Instrument** – Different types of instruments are available for filtering and can be excluded if a previous filter has been selected (e.g. when selecting the PETR4 ticker, only Cash Instrument will appear). If an instrument filter is chosen before the others, commodities and tickers will be filtered in the same way as in the previous example. As with the Investor Category filter by **clicking and holding down the Ctrl key**, it is possible to select more than one instrument simultaneously.

**Trade Type** – Divided between buy and sell or with give-up and without give-up, you can view participants who have a higher trading level for each trade type for certain filtered scenarios.

# 7 ADICIONAL FILTERS

## 7.1 Groupings





**Groupings** – In the existing lists in the allocation dashboard where participants are listed, you can group a few institutions based on Economic Groups (e.g. XP Inc, which is made up of the XP, Rico and Clear brokerage houses). To carry out the grouping, it is necessary to keep the Ctrl button pressed and click on the desired squares. When you have finished choosing, bring the mouse closer and a menu will be displayed with different options: Keep Only, Exclude and a symbol that looks like a paper clip (Group Member). When clicking on Group Member, the new grouping will appear in the ranking with the name of all the squares that make it up. Values will continue to be influenced by the selected filters.
