General Provisions

This Manual presents the procedures to calculate settlement prices for financial derivatives futures contracts whose underlying assets are interest rates, foreign exchange, stock indices, crypto assets, or commodities.

The required calculation parameters, procedures, and criteria described are changed monthly and should be consulted in the Monthly Parameter Annex for the month in question.

In the event of partial or total unavailability of the inputs needed for the methodologies described in this Manual, and/or due to events of an economic or operational nature that may hinder price calculation coordination or the application of the corresponding methodology, B3, through its Market Risk Technical Committee, may at its sole discretion, arbitrate settlement prices.

Inputs used to price futures contracts are obtained from orders and trades on the trading floor, mainly through the **electronic closing call** and the **average calculation window** (). Other trading data, prices, and economic indicators may also be used. The **electronic closing call** is a mechanism at the end of the trading session used to set a single price for all trades that occur in the call, even if orders have different prices. The **average calculation window** is a trading period that uses trades made in that period and orders open at the end of the window to define the contract settlement price in accordance with the methodologies defined in this Manual.

A set sequence of procedures is used to calculate the settlement price of electronic closing call Futures contracts. If the first procedure cannot be applied, the second will be, and so forth successively until the settlement price is determined. The procedures involve the following definitions:

Market Pricing

(i) **Valid trade**, typically denoted as the first procedure (P1), are the contract/expiration trades that meet the following conditions:

- Is present at the electronic closing call or during average calculation window.
- A minimum quantity traded (lots quantity of trade or trades grouping sum) greater than or equal to the “Minimum contracts quantity” threshold set by the Liquidity Group for the contract/expiration in question, as shown in the Monthly Parameters Annex.
- A minimum trades number carried out (how many trades separately were carried out, regardless of the quantity of each trade) greater than or equal to the “minimum trades number” limit threshold set by the contract in question, as shown in the Monthly Parameters Annex. If the limit is not explicitly defined, the minimum of 1 trade will be considered.

(ii) **Valid Order**, is defined as an electronic closing call order that meets the following three conditions:

- Is present at the electronic closing call;
- 30 seconds minimum exposure;
- A Quantity greater than or equal to the minimum quantity threshold set by the Liquidity Group for the contract/expiration in question, as shown in the Monthly Parameters Annex. Traded contracts that have the same bid or ask price are also considered when assessing the quantity of bid and ask orders.

If there is more than one valid bid/ask order, the highest bid order the lowest ask order will be considered to be the valid order.

(iii) **Valid bid-ask spread**, can be calculated in two ways, according to the Monthly Parameters Annex:

- Difference: the difference between the best **valid buy order** (VBO); and the best **valid sell order** (VSO) that is smaller than or equal to the

threshold set ($Spread_{Max.}$) by the Liquidity Group for the contract/expiration in question, as shown in the Monthly Parameters Annex. As per the condition below:

$$\begin{cases} \text{if } VSO - VBO \leq Spread_{Max.} \rightarrow Spread \text{ is valid} \\ \text{otherwise } Spread \text{ is not valid} \end{cases}$$

- **Percentual:** the difference between the best **valid buy order** (VBO); and the best **valid sell order** (VSO) divided by the mid between the best **valid buy order** (VBO) and the best **valid sell order** (VSO), that is smaller than or equal to the threshold set ($Spread_{Max.}$) by the Liquidity Group for the contract/expiration in question, as shown in the Monthly Parameters Annex. As per the condition below:

$$\begin{cases} \text{if } \frac{VSO - VBO}{\frac{VSO + VBO}{2}} \leq Spread_{Max.} \rightarrow Spread \text{ is valid} \\ \text{otherwise } Spread \text{ is not valid} \end{cases}$$

- (iv) **VWAP: Volume weighted average price**, it is the top offers weighted average of the books captured in the capture time interval defined for the product, with a total interval time T , for each registered book at t seconds inside the interval, with the first orders book is the book in the exactly at the beginning time interval, and the last orders book is the book in the second immediately before the ending time interval, resulting in a total if $N = T/t$ books inside de capture interval time.

For each registered book (i), is computed:

- OC_i , volume average price of the top bid orders, when the sum of contracts equals the minimum:

$$OC_i = \frac{\sum_n q_{i,n} * P_{i,n}}{Q_{min}}$$

$P_{i,n}$ bid offer of book i at level n ;

Q_{min} contracts minimum quantity;

$$q_{i,1} = \min\{Q_{i,1}, Q_{\min}\};$$

$$q_{i,n} = \min\{Q_{i,n}, Q_{\min} - \sum_{j=1}^{n-1} q_{i,j}\}, \text{ when } n > 1; \text{ e}$$

$Q_{i,n}$ contracts quantity at level n of book i .

- OV_i , volume average price of the top ask orders, when the sum of contracts equals the minimum:

$$OV_i = \frac{\sum_n q_{i,n} * P_{i,n}}{Q_{\min}}$$

$P_{i,n}$ ask offer of book i at level n ;

$Q_{\min}$ contracts minimum quantity

$$q_{i,1} = \min\{Q_{i,1}, Q_{\min}\};$$

$$q_{i,n} = \min\{Q_{i,n}, Q_{\min} - \sum_{j=1}^{n-1} q_{i,j}\}, \text{ when } n > 1; \text{ e}$$

$Q_{i,n}$ contracts quantity at level n of book i .

- If there was computation of OC_i and OV_i , then the Mid price (OM_i) price is defined as follows:

$$OM_i = \frac{OV_i + OC_i}{2}$$

only when the relation between OC_i and OV_i meets “Valid bid-ask spread” (iii topic of chapter) for book i .

Once all the books were analyzed, the final prices are given by the arithmetic average of the prices defined by the books i with value generated (bid, ask, mid). For the price to be considered as valid, the number of books m with price computed should be greater than the minimum for the contract M .

$$OFC = \frac{\sum_{j=1}^m OC_j}{m}, \text{ where } m \text{ is the number of books with } OC_j \text{ computed}$$

$$OFV = \frac{\sum_{j=1}^m OV_j}{m}, \text{ where } m \text{ is the number of books with } OV_j \text{ computed}$$

$OFM = \frac{\sum_{j=1}^m OM_j}{m}$, where m is the number of books with OM_j computed.

- (v) **Volume-Weighted Average Price at the End of the Closing Call**, which is the weighted average of the best offers, from the book, verified at the end of the Closing Call, for each month n .

For each book captured, for purchase ($Book_C$) and for sale ($Book_V$) respectively, at the end of the Closing Call, the average is calculated (OFC^n average for purchases, and OFV^n average for sell) of the best active orders at the end of the Closing Call ($P_{OfC,i}^n$ for buy orders, or $P_{OfV,i}^n$ for sell orders), weighted by the respective order quantity ($Q_{OfC,i}^n$ for buy orders, or $Q_{OfV,i}^n$ for sell orders).

The minimum quantity Q_{min}^n , will limit the orders to be considered in the calculation of each average, so that the sum of the quantities of each considered best offer is exactly equal to the minimum quantity. The last order to be considered, if it exceeds the minimum quantity, will be considered in the enough proportion for the sum to reach the minimum quantity on maturity n . If the sum of all Book X order quantities does not reach the Minimum Quantity, the weighted average OFX^n will not be considered valid.

$$\text{from the buy book: } OFC^n = \frac{\sum_i q_{OfC,i}^n * P_{OfC,i}^n}{Q_{min}^n}$$

$$\text{from the sell book de compra: } OFV^n = \frac{\sum_i q_{OfV,i}^n * P_{OfV,i}^n}{Q_{min}^n}$$

Where:

$$q_{OfX,1}^n = \min\{Q_{OfX,1}^n, Q_{min}^n\};$$

$$q_{OfX,i}^n = \min\{Q_{OfX,i}^n, Q_{min}^n - \sum_{j=1}^{i-1} q_{OfX,j}^n\}, \text{ when } i > 1.$$

It is possible to set a parameter to consider the trades carried out in the Closing Call, in the calculation of the Weighted Average, in case these trades do not have enough quantity to define the price using the pricing method per trades (see topic **Valid Trade**). In this case, trades will be considered together with orders (only in one of the books, buy or sell), grouped by the same trade price P_{NEG}^n and orders ($P_{OfC,i}^n$ for buy, or $P_{OfV,i}^n$ for sell), adding the quantities of offers ($Q_{OfC,i}^n$ for purchases and $Q_{OfV,i}^n$ for sell) and Q_{NEG}^n trades.

$$\text{if } P_{NEG}^n = P_{OfC,i}^n \Rightarrow QT_{OfC,i}^n = Q_{OfC,i}^n + Q_{NEG}^n$$

$$\text{if } P_{NEG}^n = P_{OfV,i}^n \Rightarrow QT_{OfV,i}^n = Q_{OfV,i}^n + Q_{NEG}^n$$

And the weighted average OC_X^n of each book will be calculated using the Total Quantities of Trades and Offers QT , for each level of the Book, until the Minimum Quantity Q_{min}^n is reached. In the same way as using orders only, if the sum of all total quantities of a book X does not reach the Minimum Quantity, the weighted average OC_X^n referring to the book will not be considered valid.

$$\text{from the buy book: } OFC^n = \frac{\sum_i qt_{OfC,i}^n * P_{OfC,i}^n}{Q_{min}^n}$$

$$\text{from the sell book: } OFV^n = \frac{\sum_i qt_{OfV,i}^n * P_{OfV,i}^n}{Q_{min}^n}$$

Where:

$$qt_{OfX,1}^n = \min\{QT_{OfX,1}^n, Q_{min}\};$$

$$qt_{OfX,i}^n = \min\{QT_{OfX,i}^n, Q_{min} - \sum_{j=1}^{i-1} qt_{OfX,j}^n\}, \text{ when } i > 1.$$

Note that orders will be considered, if they meet a minimum exposure time (t_{MIN}^n) within the Closing Call, to be considered valid. This time will be counted from the last modification of the order $t_{LastModif,i}^n$, until the end of the closing Call of expiry n ($t_{EndCall}^n$). The order must be present at the end of the closing call.

$$t_{EndCall}^n - t_{LastModif,i}^n > t_{MIN}^n$$

If the average of the buy orders OFC^n and the average of the ask orders OFV^n have been calculated and validated for a given month n , the mid price (OFM^n) will be given by the formula below, since the spread between OFV^n and OFC^n does not exceed the limit spread ($Spread_{MAX}^n$) for the expiry date:

$$OFM^n = \frac{OFC^n + OFV^n}{2},$$

only when the relation between OC_i and OV_i meets “Valid bid-ask spread” (*iii* topic of chapter) for book i .

If the mid OFM^n is valid, it will be the final price for the order step of that month n . Otherwise, and if the average bid price OFC^n and/or the average ask price OFV^n are valid, they may be used to validate **the Theoretical Price** (Fallback) for the month in question, as described in the next chapter.

Theoretical Pricing

When **Market Pricing** requirements are not met, other procedures can be adopted to determine the **Theoretical Price (TP)** for adjusting the contract respecting the conditions below.

Theoretical Pricing when there are valid futures contract orders.

If there is a **valid order**, the final settlement price (SP) of the contract is defined using the criteria below:

1. If there is a **valid buy order** (VBO), then $VBO \leq SP$:

$$SP = \max(VBO, TP)$$

2. If there is a **valid sell order** (VSO), then $SP \leq VSO$:

$$SP = \min(VSO, TP)$$

3. If there is a valid buy order (VBO) and a valid sell order (VSO), then

$$VBO \leq SP \leq VSO:$$

$$\begin{cases} \text{if } TP < VBO, & SP = VBO \\ \text{if } TP > VSO, & SP = VSO \\ \text{otherwise,} & SP = TP \end{cases}$$

The electronic closing call pricing criteria aims to maximize the quantity of traded contracts. Therefore, although orders may have different prices, all trades for the same expiration carried out at the electronic closing call are closed at a single price.

Finally, this manual presents the methodology used to define the official settlement price for each contract.

1 INTEREST RATES

1.1 Average One-Day Interbank Deposit Rate Futures Contract (DI1)

The settlement price for the Average One-Day Interbank Deposit Rate Futures Contract is expressed as an annualized interest rate.

The procedure sequence to determine the settlement price for a given DI1 expiration

If it is the last business day before contract expiration, the settlement price as a rate of the first expiration will correspond to the CDI (Interbank Deposit Certificate) rate of the day. If the contract expiring is due in January, the settlement price will be based on procedures P1 and P2, or, in their absence, the CDI reference rate of the day will be used.

P1. The settlement price will be the weighted arithmetic average of the trades carried out for that month, in the time interval according to the parameters of the Annex of Monthly Parameters of the calculation date.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average of the Mid-VWAP offer with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 1 of the Monthly Parameters Annex (the Mid-VWAP is defined in General Provisions section).

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be calculated using by summing (i) the settlement price for the expiration in question on the immediately preceding day with (ii) the settlement price variation of the expiration in question, which is calculated by linear interpolation of the day's settlement price variation in relation to the immediately preceding day of the immediately previous(*a*) and following(*p*) expirations with settlement prices determined by P1 or P2, as per equation (1.0). Linear interpolation of the settlement price's daily variation in relation to the immediately

preceding day ensures that settlement prices with missing inputs have fluctuations compatible with the fluctuation of the already traded contract expirations.

$$PA_{i,t} = PA_{i,t-1} + \left(\Delta_a + (\Delta_p - \Delta_a) \times \frac{(DC_i - DC_a)}{(DC_p - DC_a)} \right) \quad (1.0)$$

Where:

$PA_{i,t}$ = settlement price for expiration i on the calculation date resulting from the application of procedure P3, rounded to the third decimal place;

$PA_{i,t-1}$ = settlement price for expiration i on the business day prior to the calculation date;

$\Delta_a = PA_{a,t} - PA_{a,t-1}$ = difference between the settlement prices of the calculation date and the previous business day for the expiration with settlement price immediately before the interpolated expiration;

$\Delta_p = PA_{p,t} - PA_{p,t-1}$ = difference between the settlement prices of the calculation date and the previous business day for the expiration with settlement price immediately after the interpolated expiration;

DC_a = the number of calendar days between the calculation date and the expiration date a ;

DC_p = the number of calendar days between the calculation date and the expiration date p ;

DC_i = number of calendar days between the calculation date and the expiration date of the interpolated expiration i .

P3.1. If it is the first trading day of the contract i and no settlement price has been determined by procedures P1 or P2, having previous expiration (a) with a settlement price defined by P1 or P2 and a following expiration (p) with a

settlement price defined by P1 or P2, the settlement price of contract i will be obtained from the exponential interpolation of the forward term structure, given by equation (1.1):

$$PA_i = \left((1 + SP_a)^{\frac{DU_a}{252}} \times \left(\frac{(1 + PA_p)^{\frac{DU_p}{252}}}{(1 + PA_a)^{\frac{DU_a}{252}}} \right)^{\frac{DU_i - DU_a}{DU_p - DU_a}} \right)^{\frac{252}{DU_i}} - 1 \quad (1.1)$$

where:

PA_i = settlement price for the expiration i resulting from exponential interpolation, rounded to the third decimal place;

PA_a = settlement price for the expiration a immediately preceding the interpolated expiration (expiration i);

PA_p = settlement price for the expiration p immediately subsequent to the interpolated expiration (expiration i);

DU_a = number of trading days between the calculation date and the expiration date of the expiration a ;

DU_p = number of trading days between the calculation date and the expiration date of the expiration p ;

DU_i = number of trading days between the calculation date and the expiration date of the interpolated expiration i .

P4. If procedure P3 cannot be applied due to the absence of a later expiration settlement price, the settlement price for the expiration in question will be calculated using equation (1.2) by summing (i) the settlement price for the expiration in question on the immediately preceding day with (ii) the daily settlement price variation on the day immediately preceding the last expiration

settlement price. If the price obtained through this procedure does not result in a **valid order price** (i.e. the price is lower than a **valid bid price** or higher than a **valid ask price**), the settlement price will be the **valid order price** with the closest value. In this situation, this expiration ($v - 1$) will be considered a reference for the second part of the equation (1.2) for all longer expiration.

$PA_{v,t}$ = settlement price for expiration i on day t with $v - 1$ being the expiration immediately preceding v . The calculation procedure P4 uses equation (1.2), rounded to the third decimal place:

$$PA_{i,t} = PA_{i,t-1} + \Delta_{i-1,t} \quad (1.2)$$

Where:

$\Delta_{i-1,t} = PA_{i-1,t} - PA_{i-1,t-1}$ = daily variation of the expiration $i - 1$ in t .

P5. If procedure P3 cannot be applied due to the absence of a preceding expiration settlement price, including first expiration defined by P1 or P2, the following procedure is used to determine the settlement price of the expiration in question:

- E1. The settlement price is defined as the weighted average trading price at interval time defined for the contract, even if it does not have the minimum amount required (see Annex of Monthly Parameters) to be considered valid;
- E2. If there are no trades defined at E1, the weighted average of the trades made that day up until the moment before the start of the interval time of the price definition;
- E3. If there is no previous expiration settlement price as defined by E1 or E2, the one-day variation of the immediate subsequent expiration in which the settlement price was defined by P1, P2, E1, or E2 is applied to the settlement price of the previous day of the contract in question;

E4. If there is a previous expiration settlement price as defined by E1 or E2 and a later expiration defined by P1, P2, E1, or E2, the settlement price is obtained by linearly interpolating the daily settlement price variation in relation to the immediately previous day (Equation 1.0), using the immediately previous expiration where the settlement price was defined by E1 or E2 and the immediately subsequent expiration where the settlement price was defined by P1, P2, E1, or E2 as pivots in the interpolation.

1.2 DI x U.S. Dollar Spread Futures (DDI)

The ID x U.S. Dollar Spread Futures Contract settlement price is expressed as an annualized interest rate.

DDI settlement prices are calculated using non-arbitrage formulas. The methodology for calculating the first open expiration differs from the methodology for calculating other expirations. On the two days prior to the expiration date of the first open expiration, the methodology for the other expirations is not uniform, due to the rollover of the short DI x U.S. Dollar Spread Futures (short leg) of the FRA on the ID x U.S. Dollar spread (FRC) as shown in section 1.3 and used as input for the calculation of settlement prices.

P1. The settlement price will be the price established at the electronic closing call for the expiration in question.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average **valid bid prices** and **valid ask prices** with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 2 of the Monthly Parameters Annex.

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be calculated using equation (1.7) by summing (i) the settlement

price for that expiration on the day immediately prior to (ii) the settlement price variation of the expiration in question, which is calculated by linear interpolation of the day's settlement price variation in relation to the immediately preceding day of the immediately previous(*a*) and following(*p*) expirations with settlement prices determined by P1 or P2.

In this situation, this expiration ($i - 1$) will be considered a reference for the second part of the equation (1.9) for all longer expirations.

E3. If there is no previous expiration settlement price as defined by E1 or E2, the one-day variation of the immediate subsequent expiration in which the settlement price was defined by P1, P2, E1, or E2 is applied to the settlement price of the previous day of the contract in question;

E4. If there is a previous expiration settlement price as defined by E1 or E2 and a later expiration defined by P1, P2, E1, or E2, the settlement price is obtained by linearly interpolating the daily settlement price variation in relation to the immediately previous day (Equation 1.0), using the immediately previous expiration where the settlement price was defined by E1 or E2 and the immediately subsequent expiration where the settlement price was defined by P1, P2, E1, or E2 as pivots in the interpolation.

1.4 Futures on the Average Rate of One-Day Repurchase Agreements (OC1)

OC1 settlement price is expressed as an annualized interest rate and follows the same calculation procedures and parameters used for DI1 using section 1.1.

In the absence of closing call data that renders it impossible to perform the aforementioned procedures, the OC1 settlement price will be calculated using equation (1.10).

IAP settlement prices are calculated using non-arbitrage formulas. It should be noted the calculation methodology of the first open expiration differs from the calculation methodology of other expirations on the last trading day and on the expiration date.

Procedure sequence to determine the settlement price for a given DAP expiration.

P1. The settlement price will be the price established at the electronic closing call for the expiration in question based on **valid trades** (see the methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual), according to the **Quantity Limit** parameter stipulated in Table 5 of the *Monthly Parameters Annex*.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with valid bid-ask spread, calculated according to the methodology of **Volume-Weighted Average Price at the End of the Closing Call** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 5 of the *Monthly Parameters Annex*.

P3. If procedure P2 cannot be applied, the settlement price as a rate for the expiration in question will be calculated using equation (1.20)

- In the event that only some maturities meet the above parameters (**updated maturities** - $Casado_i$), and other maturities do not meet (**non-updated maturities** - $Casado_n$), the non-updated maturities ($Casado_n$) will be obtained from of updated maturities ($Casado_i$), considering:
 - the Flat Forward interpolation, if there is a $Casado_i$ with a deadline (DU_i in working days) shorter than the maturity of the interpolated $Casado_n$ (DU_n in working days), **AND** information $Casado_j$ with deadline (DU_j in working days) greater than the interpolated deadline (DU_n in working days), both obtained with information collected as described in the paragraph

above. Both $Casado_i$ and $Casado_j$, to be used, will be the closest in term, before and after $Casado_n$:

- otherwise, the repetition of $Casado_{IPCA_n}$ will be used for the closest deadline, obtained as described in the paragraph above, with earlier OR later deadlines according to the case:
 - If there is no $Casado_i$ information with term (DU_i in working days) shorter than the interpolated term (DU_n in working days), obtained as described in the paragraph above. Then we will obtain the $Casado_n$ according to the formula below, where $Casado_j$ is obtained as described in the paragraph above:

$$Casado_n = Casado_j$$

- If there is no $Casado_j$ information with term (DU_j in working days) greater than the interpolated term (DU_n in working days), obtained as described in the paragraph above. Then we will obtain the $Casado_n$ according to the formula below, where $Casado_i$ is obtained as described in the paragraph above:

- If any maturity date is met, the “IPCA Coupon Match” will be considered the one obtained at the close of the DAP on the previous day ($Casado_{n,t-1}^{B3}$):

1.9 Mexico TIE de Fondeo a Un Día Rate Futures Contract (TIE)

The settlement price for the Mexico *TIE de Fondeo a Un Día* (F-TIE) Futures Contract is expressed as an annualized interest rate, rounded to 3 decimal place.

The procedure sequence to determine the settlement price for a given expiration

On the contract expiration date, the settlement price, expressed as rate, for the first maturity will correspond to the most recent F-TIE rate, made available by the end of the adjustment determination window, provided by the Central Bank of Mexico.

P1. The settlement price will be the **weighted average** (see [General Provisions, Market Pricing, Valid Trades](#)) of the trades conducted during the capture window on the calculation date, respecting the minimum quantity of trades and contracts according to the parameters in Table 12 of the Annex of Monthly Parameters. The traded rate is rounded to the third decimal place in percentage.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average of the Mid-VWAP offer with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 12 of the Monthly Parameters Annex (the Mid-VWAP is defined in General Provisions section).

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be the value of the vertex corresponding to the maturity term on the F-TIE zero curve, constructed from the discount factors obtained by

LSEG/Refinitiv, as per Table 1.1, at the contract closing time, according to Table 12 of the Annex of Monthly Parameters, calculated by 1.22 formula, described below:

$$TxLin_{JUR^v,t} = \left(\frac{1}{FD_{JUR^v,t}} - 1 \right) \times \frac{36000}{DC_v} \quad (1.22)$$

Where:

- $TxLin_{JUR^v,t}$: is the interest rate in % per annum linear, in calendar days based on 360, according to the contract standard;
- $FD_{JUR^v,t}$: is the discount factor for the interest rate curve captured from LSEG/Refinitiv, as per Table 1.1, for vertex v , on calculation date t , for the respective contract;
- DC_v : term in calendar days for vertex v , on calculation date t ;

For trading days on B3 that are holidays in Mexico (as defined by the Bank of Mexico), the procedures described earlier will not be applied in determining the daily settlement rate and price of the contract. The settlement price will be determined by:

1.10 United States of America Secured Overnight Financing Rate Futures Contract (SFR)

The settlement price for the United States of America Secured Overnight Financing Rate (SOFR) Futures Contract is expressed as an annualized interest rate, rounded to 3 decimal place.

The procedure sequence to determine the settlement price for a given expiration

On the contract expiration date, the settlement price, expressed as rate, for the first maturity will correspond to the most recent SOFR rate, made available by the end of the adjustment determination window, provided by the Federal Reserve Bank of Nova York.

P1. The settlement price will be the **weighted average** (see [General Provisions, Market Pricing, Valid Trades](#)) of the trades conducted during the capture window on the calculation date, respecting the minimum quantity of trades and contracts according to the parameters in Table 12 of the Annex of Monthly Parameters. The traded rate is rounded to the third decimal place in percentage.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average of the Mid-VWAP offer with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 12 of the Monthly Parameters Annex (the Mid-VWAP is defined in General Provisions section).

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be the value of the vertex corresponding to the maturity term on the SOFR zero curve, constructed from the discount factors obtained by LSEG/Refinitiv, as per Table 1.1, at the contract closing time, according to Table 12 of the Annex of Monthly Parameters, calculated by 1.22 formula, described previously.

For trading days on B3 that are holidays in United States of America (as defined by the Federal Reserve Bank of New York), the procedures described earlier will not be applied in determining the daily settlement rate and price of the contract. The settlement price will be determined by:

$$PA_{SFR^{n,t}} = PA_{SFR^{n,t-1}} \times FC_t$$

Where:

$PA_{TIE^{n,t-1}}$ = Adjustment price of the SFR contract, for the respective maturity n , for the previous trading date $t-1$;

FC_t = Correction factor of the adjustment price of the SFR contract, for the trading date t , calculated as described in the draft of the respective contract.

The settle rate $TA_{SFR^{n,t}}$ will be determined by:

Where:

DC_n = term in calendar days for maturity n, on calculation date t.

1.11 Europe Euro Short-Term Rate Futures Contract (EST)

The settlement price for the Europe Euro Short-Term Rate (ESTR) Futures Contract is expressed as an annualized interest rate, rounded to 3 decimal place.

The procedure sequence to determine the settlement price for a given expiration

On the contract expiration date, the settlement price, expressed as rate, for the first maturity will correspond to the most recent ESTR rate, made available by the end of the adjustment determination window, provided by the European Central Bank.

P1. The settlement price will be the **weighted average** (see [General Provisions, Market Pricing, Valid Trades](#)) of the trades conducted during the capture window on the calculation date, respecting the minimum quantity of trades and contracts according to the parameters in Table 12 of the Annex of Monthly Parameters. The traded rate is rounded to the third decimal place in percentage.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average of the Mid-VWAP offer with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 12 of the Monthly Parameters Annex (the Mid-VWAP is defined in General Provisions section).

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be the value of the vertex corresponding to the maturity term on the ESTR zero curve, constructed from the discount factors obtained by

LSEG/Refinitiv, as per Table 1.1, at the contract closing time, according to Table 12 of the Annex of Monthly Parameters, calculated by 1.22 formula, described previously.

For trading days on B3 that are holidays in Europe (as defined by European Central Bank, TARGET2 holidays), the procedures described earlier will not be applied in determining the daily settlement rate and price of the contract. The settlement price will be determined by:

$$PA_{EST^{n,t}} = PA_{EST^{n,t-1}} \times FC_t$$

Where:

$PA_{EST^{n,t-1}}$ = Adjustment price of the EST contract, for the respective maturity n, for the previous trading date t-1;

FC_t = Correction factor of the adjustment price of the EST contract, for the trading date t, calculated as described in the draft of the respective contract.

The settle rate $TA_{EST^{n,t}}$ will be determined by:

2 FOREIGN EXCHANGE

2.1 U.S. Dollar Futures (DOL) and Mini U.S. Dollar Futures (WDO)

The U.S. Dollar Futures Contract and Mini U.S. Dollar Futures Contract settlement prices are expressed in Brazilian Reals per USD1,000 rounded to the third decimal place.

DOL settlement prices are calculated using non-arbitrage formulas. The methodology for calculating the first open expiration differs from other expirations. In the two-day period preceding the expiration date of the first open expiration, the methodology of the second expiration is not uniform due to the rollover of the FRC short leg and the rollover of the DOL from the first to the second expiration.

WDO settlement prices are the settlement prices for the respective DOL expirations.

2.1.1 First open expiration

The settlement price for the first DOL expiration is the weighted arithmetic average of the trades between **3:50-4:00 pm**¹ on the calculation date, rounded to the third decimal place.

2.1.2 Other expirations

The settlement prices for other DOL expirations are calculated using equation (2.1):

DU_n = the number of trading days between the calculation date t and the date of the n th DI1 expiration;

DC_n = the number of calendar days between the calculation date t and the calculation date of the n th DDI expiration.

When there is a DOL expiration that does not correspond to the DI1 and/or DDI, the settlement prices necessary to calculate the DOL settlement price using equation (2.1) will be calculated by interpolation, using equations (1.1) and (1.8), respectively.

2.1.3 Second open expiration

The second open DOL expiration will have its settlement price calculated differently than stipulated in the previous section, on the dates described below.

Business day preceding the last trading day of the first open expiration.

The settlement price for the second DOL open expiration is calculated using equation (2.2):

Last trading day of the first open expiration

The settlement price for the second open DOL expiration is the weighted arithmetic average of the trades carried out between 3:50-4:00 pm on the calculation date.

2.1.4 First open expiration on the last trading day

The settlement price for the first DOL, on the expiration date, is the Brazilian Real per U.S. Dollar exchange selling rate, according to the PTAX800, published by the Central Bank of Brazil on the date $t - 1$.

2.2 U.S. Dollar Swap with Reset Referencing One-Day Repurchase Agreement (SCS)

The U.S. Dollar Swap with Reset Referencing One-Day Repurchase Agreement settlement price is expressed as an annualized interest rate and follows the same procedures and calculation parameters used for the DCO, using section 1.2, of the same expiration date.

Due to the particularities of the U.S. Dollar Swap with Reset Referencing OneDay Repurchase Agreement, where the spread rates of a given expiration depend on the participant's total position in that expiration, among others, the settlement calculation is done for each participant from their positions and not in a standardized way, as in futures contracts. Each participant's positions are reset daily using equation (2.3):

VF = value of the Final Value leg;

DC_n = number of calendar days between the calculation date t and the date of the n th SCS position expiration;

i_s = B3 reference rate for Selic x U.S. Dollar transactions, which correspond to the DCO settlement price with the same expiration date. When said expiration is

absent in the DCO, the reference rate will be calculated by interpolating the DCO settlement prices. The interpolation is explained in equation (1.8);

$DOLPtax_{t-1}$ = Brazilian Real per U.S. Dollar exchange selling rate using PTAX800, published by the Central Bank of Brazil on the date $t - 1$;

$Selic_t$ = Selic rate published by the Central Bank of Brazil on the date t .

2.3 Currency Futures in Brazilian Real

Settlement prices in Brazilian Real are calculated using non-arbitrage formulas. The calculation methodology for the first open contract differs from that of the other contracts on the last trading day and the expiration date.

This section has been structured in a way that presents a general formula (section 2.3.1) that accommodates all currency parity relationships and the calculation of foreign exchange coupons for different currencies. Table 2.1 in section 2.3.4 provides all the calculation parameters to be used in sections 2.3.1 and 2.3.2. Sections 2.3.2 and 2.3.3 determine the settlement price for the first contract one business day prior (fixing) and on the expiration day, respectively.

2.3.1 General Formula: All Expirations

The settlement price of Brazilian real currency futures contracts is expressed by the following equation:

- For maturity n of the currency X contract being calculated that coincides with the respective maturity of the Brazilian real to commercial dollar futures contract (DOL), PA_{DOL^n} will be the closing settlement price of the respective maturity n of the Brazilian real to commercial dollar futures contract (DOL) on date t ;
- For maturity n of the currency X contract being calculated that does not coincides with the respective maturity of the Brazilian real to commercial dollar futures contract (DOL), PA_{DOL^n} will be the vertex of the *Brazilian Real X Dollar Forward Curve* (PTX), as described in chapter 4.1 of the Curves Manual, whose term corresponds to the maturity n being calculated on date t , multiplied by 1000, as follows:

N_{DOL} = Dolar future (DOL) notional amount of 1,000 Reais;

α = variable depending on the parity relationship of currency X. Based on Table 2.1:

If ρ = Direct, then $\alpha = 1$;

$PA_{(USD,X)^n}$ = Future settlement value of currency X in United States dollars of the nth expiration. In Table 2.1 there's the code of the respective future in US dollars (USD, X);

$N_{(USD,X)}$ = Notional amount in dollars of currency X, as defined in Table 2.1;

N_X = Notional amount in currency X , as defined in Table 2.1.

2.3.2 General Formula: First open expiration on the last trading day (Fixing)

On the expiration date, the settlement price will be calculated using equation (2.5):

This exchange rate is calculated by The World Markets Company PLC ("WM") and published by Reuters Limited ("Reuters"), on page WMRSPOT02, under the quote WM/Reuters Closing Spot Rate, on the calculation date t . If the currency is ARB or CLP, their rate will be, respectively, calculated by *Mercado Abierto Electrónico* (MAE) and Chilean Central Bank. When the rate is unavailable due to a holiday abroad, the rate from day $t-1$ will be used.

N_X = Notional amount of currency X , defined in Table 2.1;

TD_t = Exchange rate of Brazilian reais per United States dollar, selling rate, disclosed by the Central Bank of Brazil through Sisbacen, transaction PTAX800, option "5", closing rate, for settlement in two days, on the calculation date t .

2.3.3 First open expiration on the expiration day

On the expiration date, the settlement price will be the settlement price calculated on the last trading day, as per subsection 2.3.2.

2.3.4 Calculation definitions for all currencies in Brazilian reais

2.3.5 Australian Dollar Futures (AUD)

The settlement price for the Australian Dollar Futures Contract is expressed in Brazilian reais per AUD1,000 and rounded to the third decimal.

The AUD settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.6 Canadian Dollar Futures (CAD)

The settlement price for the Canadian Dollar Futures Contract is expressed in Brazilian reais per CAD1,000 and rounded to the third decimal.

The CAD settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.7 New Zealand Dollar Futures (NZD)

The settlement price for the New Zealand Dollar Futures Contract is expressed in Brazilian reais per NZD1,000 and rounded to the third decimal.

The NZD settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.8 Euro Futures (EUR) and Mini Euro Futures (WEU)

The settlement price for the Euro Futures and Mini Euro Futures Contracts are expressed in Brazilian reais per EUR1,000 and rounded to the third decimal.

The EUR and WEU settlement price are calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.9 Swiss Franc Futures (CHF)

The settlement price for the Swiss Franc Futures Contract is expressed in Brazilian reais per CHF1,000 and rounded to the third decimal.

The CHF settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.10 Yuan Dollar Futures (CNY)

The settlement price for the Yuan Dollar Futures Contract is expressed in Brazilian reais per CNY10,000 and rounded to the third decimal.

The CNY settlement price is calculated using the equation 2.6:

The TRY settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.13 Argentine Peso Futures (ARB)

The settlement price for the Argentine Peso Futures Contract is expressed in Brazilian reals per ARB1,000 and rounded to the third decimal.

The ARB settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.14 Chilean Peso Futures (CLP)

The settlement price for the Chilean Peso Futures Contract is expressed in Brazilian reals per CLP1,000,000 and rounded to the third decimal.

The CLP settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.15 Mexican Peso Futures (MXN)

The settlement price for the Mexican Peso Futures Contract is expressed in Brazilian reals per MXN10,000 and rounded to the third decimal.

The MXN settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.16 Yen Futures (JPY)

The settlement price for the Yen Futures Contract is expressed in Brazilian reals per JPY100,000 and rounded to the third decimal.

The JPY settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.3.17 South African Rand Futures Contract (ZAR)

The settlement price for the South African Rand Futures Contract is expressed in Brazilian reals per ZAR10,000 and rounded to the third decimal.

The ZAR settlement price is calculated using the equations from the General Formula Section, based on the definitions provided in Table 2.1.

2.4 Currency Futures in American Dollars

Currency future settlement prices in american dollars are calculated based on the 4:00 PM reference price from Refinitiv/LSEG. The calculation methodology for the first open contract differs from that of the other contracts on the last trading day and the expiration date.

This section has been structured in a way that presents a general formula (section 2.4.1) that accommodates the settlement calculation for all currencies. Table 2 in section 2.3.4 lists all the captured maturities from the provider. Sections 2.4.3 and 2.4.4 determine the settlement price for the first contract one business day prior (fixing) and on the expiration day.

2.4.1 All Open Expirations

The settlement price of the currency for each of the enabled curve vertices is given by equation (2.9).

On the expiration date, the settlement price will be the settlement price calculated on the last trading day, as per subsection 2.4.2.

2.4.4 U.S. Dollar per Euro Futures (EUP)

The settlement price for the U.S. Dollar per Euro Futures Contract is expressed in American Dollars per EUR1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.5 U.S. Dollar per Australian Dollar Futures (AUS)

The settlement price for the U.S. Dollar per Australian Dollar Futures Contract is expressed in American Dollars per AUD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.6 U.S. Dollar per British Pounds Sterling (GBR)

The settlement price for the U.S. Dollar per British Pounds Sterling Futures Contract is expressed in American Dollars per GBP1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.7 Chinese Yuan per U.S. Dollar Futures (CNH)

The settlement price for the Chinese Yuan per U.S. Dollar Futures Contract is expressed in Chinese Yuan per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.8 Swiss Franc per U.S. Dollar Futures (SWI)

The settlement price for the Swiss Franc per U.S. Dollar Futures Contract is expressed in Swiss Franc per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.9 Chilean Peso per U.S. Dollar Futures (CHL)

The settlement price for the Chilean Peso per U.S. Dollar Futures Contract is expressed in Chilean Peso per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.10 Japanese Yen per U.S. Dollar Futures (JAP)

The settlement price for the Japanese Yen per U.S. Dollar Futures Contract is expressed in Japanese Yen per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.11 Mexican Peso per U.S. Dollar Futures (MEX)

The settlement price for the Mexican Peso per U.S. Dollar Futures Contract is expressed in Mexican Peso per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.12 Norwegian Krone per U.S. Dollar Futures (NOK)

The settlement price for the Norwegian Krone per U.S. Dollar Futures Contract is expressed in Norwegian Krone per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.13 U.S. Dollar Futures per New Zealand Dollar Futures (NZL)

The settlement price for the U.S. Dollar Futures per New Zealand Dollar Futures Contract is expressed in American Dollars per NZD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.14 Canadian Dollar per U.S. Dollar Futures (CAN)

The settlement price for the Canadian Dollar per U.S. Dollar Futures Contract is expressed in Canadian Dollar per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.15 Russian Ruble per U.S. Dollar Futures (RUB)

The settlement price for the Russian Ruble per U.S. Dollar Futures Contract is expressed in Russian Ruble per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.16 Swedish Krona per U.S. Dollar Futures (SEK)

The settlement price for the Swedish Krona per U.S. Dollar Futures Contract is expressed in Swedish Krona per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.17 Turkish Lira per U.S. Dollar Futures (TUQ)

The settlement price for the Turkish Lira per U.S. Dollar Futures Contract is expressed in Turkish Lira per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

2.4.18 South African Rand per U.S. Dollar Futures (AFS)

The settlement price for the South African Rand per U.S. Dollar Futures Contract is expressed in South African Rand per USD1,000 to 3 decimal places.

The settlement price is calculated using equations 2.9 and 2.10.

3 EQUITIES

3.1 Ibovespa Futures (IND) and Mini Ibovespa Futures (WIN)

The settlement prices for the Ibovespa Futures Contract (or Bovespa Index) and for the Mini Ibovespa Futures Contract are expressed as index point values in Brazilian Reals, each point BRL1.00.

IND settlement prices are calculated using non-arbitrage formulas. It should be noted that the calculation methodology of the first open expiration differs from the methodology for calculating other expirations. On the expiration date of the first open expiration, the methodology for calculating all expirations will also be different.

WIN settlement prices are the settlement prices of the respective IND expirations.

3.1.1 First open expiration

The settlement price for the first IND expiration is the weighted arithmetic average of the trades carried out for that month, in the time interval according to the parameters of Table 8 of the Annex of Monthly Parameters of the calculation date.

3.1.2 Reference price for the Structure Ibovespa rollover transaction (IR1)

The IR1 reference price will be used as an input for calculating the settlement price for other IND expirations because the IR1 has greater liquidity than the long IND expirations that compose the IR1 transaction.

The rollover transaction has no settlement price, but the spread between the two IND expirations, that compose the transaction, provides a reference price.

Procedure Sequence to determine the IR1 reference price

The reference price resulting from any procedure will respect valid order prices.

P1. The reference price will be the price established at the electronic closing call for the expiration in question.

P2. If procedure P1 cannot be applied, the reference price for the expiration in question will be the average **valid bid prices** and **valid ask prices** with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 3 of the Monthly Parameters Annex.

P3. If procedure P2 cannot be applied, the expiration in question will have no reference price

3.1.3 Other Expirations

Procedure sequence to determine the settlement price for other IND expirations

P1. If the IR1 for the IND expiration has a reference price, the corresponding settlement price will be given according to equation (3.1) by the sum of (i) the settlement price for the first expiration and (ii) the IR1 reference price:

2. If the expiration in question has not had its settlement price calculated based on the IR1 reference price at any date prior to the calculation date, the cost of carry will be the implied cost of carry in the settlement price for

the IND expiration immediately prior to the n th expiration, rounded to the fourth decimal place. This cost will be determined by equation (3.3) or **equal to the previous day's cost of carry** if the settlement price for the immediately preceding expiration is calculated according to the trading average.

The settlement price for the first IND expiration is the Ibovespa settlement, calculated according to the arithmetic average of the values of the Ibovespa index published by B3 every 30 seconds of the last three trading hours in the spot market, excluding the closing call.

Second open expiration

The settlement price for the second IND expiration is the weighted arithmetic average of the trades carried out for that month, in the time interval according to the parameters of Table 8 of the Annex of Monthly Parameters of the calculation date.

b) Other open expirations

Procedure Sequence to determine the settlement price for other expirations

P1. When the IR1 of the second expiration for the IND expiration to be quoted has a reference price, the corresponding settlement price will be given using equation (3.5) by the sum of (i) the settlement price for the second expiration and (ii) the IR1 reference price:

The publications to be performed refers to the initial expected

quantity for the calculation period subtracted from the performed quantity previously from the interruption. The remaining publications refer to the quantity of possible publications to be realized in the negotiation period.

3.2 IBrX-50 Futures (BRI)

The settlement price for the IBrx-50 Futures Contract is expressed as index point values in Brazilian Reals, each point BRL10.00.

BRI settlement prices are calculated using non-arbitrage formulas. The calculation methodology of the first open expiration differs from that of other expirations on expiration date.

3.2.3 Calculation of settlement index in case of interruption, such as circuit breaker

In case of interruption during settlement index calculation period, a new weight rate will be attributed to published index values after interruption. This way, the weight rate applied in the settlement index calculation becomes the rate between

the quantity of publications to be performed and the quantity of remaining publications. The publications to be performed refers to the initial expected quantity for the calculation period subtracted from the performed quantity previously from the interruption. The remaining publications refer to the quantity of possible publications to be realized in the negotiation period.

3.3 S&P 500 Index Futures (ISP) and Micro S&P 500 Futures (WSP)

The settlement price for the **S&P 500 Index Futures** is expressed as index point values in Brazilian Reals, rounded to the second decimal place. WSP settlement prices are the settlement prices of the respective ISP expirations.

ISP settlement prices are calculated from a preferential sequence of procedures. The methodology for calculating the first open expiration differs from the methodology for calculating other expirations on expiration date.

3.3.1 All open expirations

The CME Group reference price for ISP expirations is defined as the price determined from the following preferential procedure sequence carried out after the end of the contract closing call at B3:

- a) settlement price for the S&P 500 Futures Contract published by the CME Group.
- b) If settlement prices are not available due to holiday in the U.S., the S&P 500 Futures Contract reference price will be the CME Group S&P 500 Futures Contract settlement price from the previous day.

The settlement price resulting from any procedure will satisfy B3 trading platform **valid order** requirements.

Procedure sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of valid trades (see *General Provisions* section) within the average calculation window according to the parameters shown in Table 4 of the *Monthly Parameters Annex* for the afore-mentioned contract.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with valid bid-ask spread, calculated according to the methodology of **VWAP: Volume weighted average price** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 4 of the *Monthly Parameters Annex*.

P3. If procedure P1 or P2 cannot be applied, the settlement price will be given by the sum of (i) the CME Group reference price for the expiration in question, (ii) the spread between the prices of the contract traded on the B3 and the CME Group calculated based on the first expiration according to equation (3.10). If the first expiration has no settlement price calculated based on procedure P1 or P2, the spread will be zero. Equation (3.11) presents the calculation of the settlement price by means of procedure P3.

3.3.2 First open expiration on the last trading day

The settlement price for the first ISP expiration on the expiration date is the settlement price used by the CME Group for settlement of that expiration. This price can be found at the Bloomberg terminal under the ticker: SPXSET Index QR. However, B3 will disclose the price only at the close of the day together with the other adjustment prices for other maturities.

On the expiration date, due to the migration of liquidity from the first to the second expiration, the spread between prices of the contract traded at B3 and the CME Group, calculated according to equation (3.10), is calculated using the second expiration.

3.4 FTSE/JSE Top40 Index Futures (JSE)

The settlement price for the BVMF FTSE/JSE Top40 Futures Contract is expressed in index point values in Brazilian Reals, reported with zero decimal places.

The calculation methodology of the first open expiration differs from other expirations on the expiration date.

3.4.1 All open expirations

The settlement price is the settlement price for the respective expiration of the Top40 FTSE/JSE Futures Index published by the Johannesburg Stock Exchange.

3.4.2 First open expiration on the last trading day

The settlement price for the first JSE expiration on the expiration date is the settlement price for the respective expiration of the Top40 FTSE/JSE Index Futures published by the Johannesburg Stock Exchange.

3.5 Hang Seng Index Futures (HSI)

The settlement price for the BVMF Hang Seng Index Futures Contract is expressed in index points values in Brazilian Reals, reported with zero decimal places.

The calculation methodology of the first open expiration differs from other expirations on the expiration date.

3.5.1 All open expirations

The settlement price is the settlement price for the respective expiration of the BVMF Hang Seng Index Futures published by the Hong Kong Exchanges and Clearing Limited.

3.5.2 First open expiration on the last trading day

The settlement price for the first HSI expiration on the expiration date is the settlement price for the respective expiration of the BVMF Hang Seng Index Futures published by the Hong Kong Exchanges and Clearing Limited.

3.6 MICEX Index Futures (MIX)

The settlement price for the BVMF MICEX Index Futures Contract is expressed in index point values in Brazilian Reals, reported with zero decimal places.

The calculation methodology of the first open expiration differs from other expirations on the expiration date.

3.6.1 All open expirations

The settlement price is the settlement price for the respective expiration of the BVMF Hang Seng Index Futures published by the MICEX-RTS.

3.6.2 First open expiration on the last trading day

The settlement price for the first MIX expiration on the expiration date is the settlement price for the respective expiration of the BVMF MICEX Index Futures published by the MICEX-RTS.

3.7 S&P Merval Futures (IMV)

The settlement price for the S&P Merval Futures Futures Contract is expressed in index point values in Brazilian Reals, reported with zero decimal places.

IMV settlement prices are calculated from a preferential sequence of procedures. The methodology for calculating the first open expiration differs from the methodology for calculating other expirations on expiration date.

3.7.1 All open expirations

The BYMA reference price for IMV expirations is defined as the price determined from the following preferential procedure sequence carried out after the end of the contract closing call at B3:

- a) Settlement price for the S&P Merval Futures Contract published by BYMA;
- b) If settlement prices are not available due to holiday in Argentina, the S&P Merval Futures Contract reference price will be the BYMA S&P Merval Futures Contract settlement price from the previous day.
- c) If the settlement prices are not available due to time zone difference, the S&P Merval Futures Contract trade price will be BYMA trading platform price nearest to the end of the IMV closing call at B3.
- d) If the trade price on BYMA trading platform nearest to the end of the closing call was before the start of the ISP closing call at B3, the reference price will be the sum of (i) the BYMA Group reference price for the first expiration and (ii) the difference between the settlement prices published by BYMA on the prior business day for the non-trading expiration on the BYMA platform and the first expiration calculated according to equation (3.12)

If procedure P1 or P2 cannot be applied, the settlement price will be given by the sum of (i) the BYMA reference price for the expiration in question, (ii) the spread between the prices of the contract traded on the B3 and the BYMA calculated based on the first expiration according to equation (3.13). If the first expiration has no settlement price calculated based on procedure P1 or P2, the spread will be zero. Equation (3.14) presents the calculation of the settlement price by means of procedure P3.

The settlement price for the first IMV expiration on the expiration date is the settlement price used by BYMA for settlement of that expiration.

On the expiration date, due to the migration of liquidity from the first to the second expiration, the spread between prices of the contract traded at B3 and BYMA, calculated according to equation (3.13), is calculated using the second expiration.

3.8 Nikkei 225 Futures Contract (INK)

The settlement price for the Nikkei 225 Futures Contract is expressed in index points values in Brazilian Reals, reported with zero decimal places.

INK settlement prices are calculated from a preferential sequence of procedures. The methodology for calculating the first open expiration differs from the methodology for calculating other expirations on expiration date.

3.8.1 All open expirations

The TSE reference price for INK expirations is defined as the price determined from the following preferential procedures sequence carried out after the end of the contract closing call at B3:

- a) settlement price for the Nikkei 225 Futures Contract published by the TSE;
- b) If settlement prices are not available due to holiday in Japan or USA, the INK reference price will be the Nikkei 225 Futures Contract settlement price from the previous day as published by the TSE.
- c) If the settlement prices are not available due to time zone difference, the Nikkei 225 Futures Contract trade price will be the TSE trading platform price nearest to the end of the INK closing call at B3.
- d) If the trade price on the TSE trading platform nearest to the end of the closing call was before the start of the INK closing call at B3, the reference

price will be the sum of (i) the CME Group reference price for the first expiration and (ii) the difference between the settlement prices published by CME Group on the previous business day for the non-trading expiration on the CME Group platform and the first expiration calculated according to equation (3.15)

3.8.2 First open expiration on the last trading day

The settlement price for the first INK expiration on the expiration date is the settlement price used by the TSE for settlement of that expiration.

On the expiration date, due to the migration of liquidity from the first to the second expiration, the spread between prices of the contract traded at B3 and the TSE, calculated according to equation (3.16), is calculated using the second expiration.

3.9 Stock Futures

The settlement price for the Stock Futures Contract is expressed in Brazilian Reals per share. The price is disclosed to Two decimal places, rounded to the second decimal place.

3.9.1 All open expirations

Procedure sequence to determine the settlement price for a given expiration of the contract

The procedure for determining the settlement price for a given expiration of the contract is a non-arbitrage relationship between (i) the closing price of the stock, (ii) interest rate and (iii) the average rate of stock rental for the day.

3.10.1 All open expirations

The Eurex reference price for DAX expirations is defined as the price determined from the following preferential procedure sequence carried out after the end of the contract closing call at B3:

- a) settlement price for the DAX Futures Contract published by the Eurex;

- b) If settlement prices are not available due to holiday in the trading location, the DAX reference price will be the DAX Futures Contract settlement price from the previous day as published by the Eurex.
- c) If the settlement prices are not available due to time zone difference, the DAX Futures Contract trade price will be the Eurex trading platform price nearest to the end of the DAX closing call at B3.
- d) If the trade price on the Eurex trading platform nearest to the end of the closing call was before the start of the DAX closing call at B3, the reference price will be the sum of (i) the Eurex reference price for the first expiration and (ii) the difference between the settlement prices published by Eurex on the previous business day for the non-trading expiration on the Eurex platform and the first expiration calculated according to equation (3.19)

In the event the day's settlement prices are unavailable due to a public holiday trading location, attention must be paid to the domestic market, in the case of **invalid orders** during the trading session. In the event of a conflict between the closing price calculated by the P3 procedure and the trading price (s), or between the price (s) of **invalid offers**, during the B3 trading session, the settlement price may be defined at the discretion of B3 in order to adapt to the domestic market, upon approval by the B3 CCP Technical Risk Committee.

3.10.2 First open expiration on the last trading day

The settlement price for the first DAX expiration on the expiration date is the settlement price used by the Eurex for settlement of that expiration.

On the expiration date, due to the migration of liquidity from the first to the second expiration, the spread between prices of the contract traded at B3 and the Eurex, calculated according to equation (3.20), is calculated using the second expiration.

3.11 Euro Stoxx 50 Futures Contract (ESX)

The settlement price for the ESX Futures Contract is expressed in index points values in Brazilian Reals, reported with zero decimal places.

ESX settlement prices are calculated from a preferential sequence of procedures. The methodology for calculating the first open expiration differs from the methodology for calculating other expirations on expiration date.

3.11.1 All open expirations

The Eurex reference price for ESX expirations is defined as the price determined from the following preferential procedure sequence carried out after the end of the contract closing call at B3:

- a) settlement price for the ESX Futures Contract published by the Eurex;
- b) If settlement prices are not available due to holiday in the trading location, the ESX reference price will be the ESX Futures Contract settlement price from the previous day as published by the Eurex.
- c) If the settlement prices are not available due to time zone difference, the ESX Futures Contract trade price will be the Eurex trading platform price nearest to the end of the ESX closing call at B3.
- d) If the trade price on the Eurex trading platform nearest to the end of the closing call was before the start of the ESX closing call at B3, the reference price will be the sum of (i) the Eurex reference price for the first expiration and (ii) the difference between the settlement prices published by Eurex on the previous business day for the non-trading expiration on the Eurex platform and the first expiration calculated according to equation (3.22)

The settlement price resulting from any procedure will satisfy B3 trading platform **valid order** requirements.

P1. The settlement price will be the price established at the electronic closing call for the expiration in question.

P2. If procedure P1 cannot be applied, the settlement price will be the average **valid bid prices** and **valid ask prices** with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 4 of the Monthly Parameters Annex.

P3. If procedure P1 or P2 cannot be applied, the settlement price will be given by the sum of (i) the Eurex reference price for the expiration in question, (ii) the spread between the prices of the contract traded on the B3 and the Eurex calculated based on the first expiration according to equation (3.23). If the first expiration has no settlement price calculated based on procedure P1 or P2, the

spread will be zero. Equation (3.24) presents the calculation of the settlement price by means of procedure P3.

In the event of a conflict between the closing price calculated by the P3 procedure and the trading price (s), or between

the price (s) of **invalid offers**, during the B3 trading session , the settlement price may be defined at the discretion of B3 in order to adapt to the domestic market, upon approval by the B3 CCP Technical Risk Committee.

3.10.2 First open expiration on the last trading day

The settlement price for the first ESX expiration on the expiration date is the settlement price used by the Eurex for settlement of that expiration.

On the expiration date, due to the migration of liquidity from the first to the second expiration, the spread between prices of the contract traded at B3 and the Eurex, calculated according to equation (3.23), is calculated using the second expiration.

3.12 Real Estate Investment Fund Index Futures (XFI)

The settlement price for the Real Estate Investment Fund Index Futures Contract (XFI) is expressed as index point.

3.12.1 All open expirations

Procedure Sequence to determine the settlement price for a given expiration of the contract

- P1. The settlement price will be calculated using the average price of **valid trades** (see General Provisions section) within the **average calculation window** according to the parameters shown in Table 10 of the Monthly Parameters Annex for the afore mentioned contract.
- P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average **valid bid** prices and **valid ask** prices with **valid bid-ask spreads** for that expiration as per the parameters stipulated in Table 10 of the Monthly Parameters Annex.
- P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be defined according to the equation (3.25).

3.12.2 First open expiration on the last trading day

The settlement price for the first XFI expiration is the Real Estate Investment Fund settlement index calculated using the arithmetic average of the index values published by B3 every 30 seconds in the last three trading hours of the spot market, excluding the closing call.

3.13 Small Caps Index Futures (SML)

The settlement price for the Small Caps Index Futures Contract (SML) is expressed in Brazilian reais per index points to 2 decimal places.

3.13.1 All open expirations

Procedure Sequence to determine the settlement price for a given expiration of the contract

- P1. The settlement price will be calculated using the average price of **valid trades** (see General Provisions section) within the **average calculation window** according to the parameters shown in Table 11 of the Monthly Parameters Annex for the afore mentioned contract.
- P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with

valid bid-ask spread, calculated according to the methodology of **VWAP: Volume weighted average price** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 11 of the *Monthly Parameters Annex*.

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be defined according to the equation (3.28).

3.13.2 First open expiration on the last trading day

The settlement price for the first SML is the Small Caps index settlement indicator calculated using the arithmetic average of the index values published by B3 every 30 seconds in the last three trading hours of the spot market, excluding the closing call

3.14 Bovespa B3 BR+ Index Futures (MBR)

The settlement price for the Bovespa B3 BR+ Index Futures Contract (IBBR) is expressed in Brazilian reais per index points to 2 decimal places.

3.14.1 All open expirations

Procedure Sequence to determine the settlement price for a given expiration of the contract

- P1. The settlement price will be calculated using the average price of **valid trades** (see General Provisions section) within the **average calculation window** according to the parameters shown in Table 11 of the Monthly Parameters Annex for the afore-mentioned contract.
- P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with valid bid-ask spread, calculated according to the methodology of **VWAP: Volume weighted average price** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 11 of the *Monthly Parameters Annex*.
- P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be defined according to the equation (3.31).

If it is the first trading day of the contract n and no settlement price has been determined by procedures P1 or P2, having previous expiration (a) with a settlement price defined by P1 or P2 and no following expiration (p) with a settlement price defined by P1 or P2, the settlement price of contract n will be defined by the extrapolation flat, given in the Section 1.4.8 in the B3 Curves Manual.

3.14.2 First open expiration on the last trading day

The settlement price for the first IBBR is the IBBR index settlement indicator calculated using the arithmetic average of the index values published by B3 every 30 seconds in the last three trading hours of the spot market, excluding the closing call.

4 COMMODITIES

The procedures for calculating settlement prices for commodities futures contracts are defined below. The settlement price resulting from any procedure must respect the **valid orders**.

4.1 Cash Settled Live Cattle Futures Contract (BGI)

The settlement price for the Cash Settled Live Cattle Futures Contract (BGI) is expressed in Brazilian Reals per 330 arrobas (about 10.7 thousand pounds), to two decimal places rounded to the second decimal place.

Procedure Sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of indirect (distinct intermediaries) **valid trades** within the **average calculation window** according to the parameters shown in Table 6 of the Monthly Parameters Annex for the afore-mentioned contract.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) calculated according to the methodology of **VWAP** (see methodology in the [GENERAL PROVISIONS, Market Pricing, \(iv\) VWAP](#)) with books checked every 1 second, and observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 6 of the *Monthly Parameters Annex*.

P3. If the P2 procedure cannot be applied, the settlement price for the maturity in question will be determined as follows, for each maturity (equation 4.1):

1. identify, into the season or off-season group to the corresponding maturity to be calculated (n), the maturities whose pricing will be determined by the P1 or P2 procedures;

2. between these maturities, identify the maturity with the greatest liquidity (*key*), that is, the maturity with most open contracts in the previous trading day;
3. for this maturity (*key*), the additive variation will be calculated, between the previous trading date settlement price ($SP_{BGI,t-1}^{key}$) and the current trading date settlement price ($SP_{BGI,t}^{key}$);
4. then the additive variation is applied to the previous day settlement price, of the maturity to be priced ($SP_{BGI,t-1}^n$).

If two or more maturities have the same number of open contracts, the maturity with the shortest term in business days between the maturity date of this one and the calculation date (t) will be used. The season or off-season groups are defined annually and follow the distribution in Table 7 of the Monthly Parameters Annex.

2. from these *keys* maturities, the period in working days between the maturity n and each *key* maturity day is calculated;
3. the *key* used in P4 procedure is the shortest period. This will be used in the same equation as the P3 procedure (equation 4.1).

If two due dates have the same number of periods, the *key* maturity will be the closest to the due date.

P5. If there are no expiration determined by P1 or P2, the settlement price will be the settlement price from the previous trading session, according to equation (4.2):

If it is the first trading day of the contract n and no settlement price has been determined by procedures P1 or P2, having previous expiration (a) with a settlement price defined by P1 or P2 and no following expiration (p) with a settlement price defined by P1 or P2, the settlement price of contract n will be defined by the extrapolation flat, given in the Section 1.4.8 in the B3 Curves Manual.

4.2 4/5 Arabica Coffee Futures (ICF)

The settlement price for the 4/5 Arabica Coffee Futures Contract is expressed in U.S. Dollars per 100 bags, to two decimal places rounded to the second decimal place.

Procedure Sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of indirect (distinct intermediaries) **valid trades** within the **average calculation window** according to the parameters shown in Table 6 of the Monthly Parameters Annex for the afore-mentioned contract.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) calculated according to the methodology of **VWAP** (see methodology in the [GENERAL PROVISIONS, Market Pricing, \(iv\) VWAP](#)) with books checked every 1 second, and observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 6 of the *Monthly Parameters Annex*. If the expiration in question doesn't have a valid mid, the settlement price for it will be:

P2.1. Price determined from structured Arabica Coffee rollover (CR1) transactions carried out throughout the day, provided that the short or long leg carry settlement prices determined from the trades (P1) or average valid bid-ask prices (P2). The settlement price will be calculated from equation (4.3) if the expiration to be calculated is the long leg or (4.4) if the expiration to be calculated is the short leg.

The settlement price for the Cash Settled Hydrous Ethanol Futures Contract is expressed in Brazilian Reals per 30 cubic meters, to two decimal places rounded to the second decimal place.

Procedure sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of indirect (distinct intermediaries) **valid trades** within the **average calculation window** according to the parameters shown in Table 6 of the Monthly Parameters Annex for the afore-mentioned contract.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) calculated according to the methodology of **VWAP** (see methodology in the [GENERAL PROVISIONS, Market Pricing, \(iv\) VWAP](#)) with books checked every 1 second, and observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 6 of the *Monthly Parameters Annex*.

P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be the previous day's settlement price.

P4.1. If it is the first trading day of the contract n and no settlement price has been determined by procedures P1 or P2, having previous expiration (a) with a

settlement price defined by P1 or P2 and a following expiration (*p*) with a settlement price defined by P1 or P2, the settlement price of contract *n* will be defined by the exponential interpolation, given in the Section 1.4.1 in the B3 Curves Manual.

P4.2. If it is the first trading day of the contract *n* and no settlement price has been determined by procedures P1 or P2, having previous expiration (*a*) with a settlement price defined by P1 or P2 and no following expiration (*p*) with a settlement price defined by P1 or P2, the settlement price of contract *n* will be defined by the extrapolation flat, given in the Section 1.4.8 in the B3 Curves Manual.

4.4 Cash Settled Corn Futures Contract (CCM)

The settlement price for the Cash Settled Corn Futures Contract is expressed in Brazilian Reals per 450 bags of 60 net kilograms, to two decimal places rounded to the second decimal place.

Procedure Sequence to determine the settlement price for a given expiration of the contract

1. identify, into the season or off-season group to the corresponding maturity to be calculated (n), the maturities whose pricing will be determined by the P1 or P2 procedures;
2. between these maturities, verify the maturity with the greatest liquidity (key), that is, the maturity with most open contracts in the previous trading day;
3. for this maturity (key), the additive variation will be calculated, between the previous trading date settlement price ($SP_{CCM,t-1}^{key}$) and the current trading date settlement price ($SP_{CCM,t}^{key}$);
4. then the additive variation is applied to the previous day settlement price, of the maturity to be priced ($SP_{CCM,t-1}^n$).

If two or more maturities have the same number of open contracts, the maturity with the shortest term in business days between the maturity date of this one and the calculation date (t) will be used. The season or off-season groups are defined annually and follow the distribution in Table 7 of the Monthly Parameters Annex.

4.5 Cash Settled Soybean Futures Contract at the CME Group Mini Soybean Futures Contract Price (SJC)

The settlement price for the Cash Settled Soybean Futures Contract at the Price of the CME Group Mini Soybean Futures Contract is expressed in U.S. Dollars per 450 bags of 60 net kilograms, to four decimal places rounded to the fourth decimal place.

The settlement price for all SJC expirations are calculated based on the settlement prices of the respective CME Group Mini Soybean Futures expiration according to equation (4.9).

Procedure Sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of indirect (distinct intermediaries) **valid trades** within the **average calculation window** according to the parameters shown in Table 6 of the Monthly Parameters Annex for the afore-mentioned contract.

P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) calculated according to the methodology of **VWAP** (see methodology in the [GENERAL PROVISIONS, Market Pricing, \(iv\) VWAP](#)) with books checked every 1 second, and observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 6 of the *Monthly Parameters Annex*.

P3. If it is not possible to apply procedure P2, the settlement prices of all SOY maturities are calculated from the settlement prices of the respective maturity of the CME Group (SAS South American Soybean futures) contract, according to equation (4.10).

If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) calculated according to the methodology of **VWAP** (see methodology in the [GENERAL PROVISIONS, Market Pricing, \(iv\) VWAP](#)) with books checked every 1 second, and observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 6 of the *Monthly Parameters Annex*.

P3. If the P2 procedure cannot be applied, the settlement price for the maturity in question will be determined as follows, for each maturity (equation 4.12):

1. identify, into the season or off-season group to the corresponding maturity to be calculated (n), the maturities whose pricing will be determined by the P1 or P2 procedures;
2. between these maturities, verify the maturity with the greatest liquidity (key), that is, the maturity with most open contracts in the previous trading day;

5 SOVEREIGN DEBT INSTRUMENTS

5.1 Ten-Year U.S. Treasury Note Futures Contract (T10)

The settlement price for the Ten-Year U.S. Treasury Note Futures Contract (T10) is expressed in U.S. Dollars per unit.

The settlement prices of all T10 maturities are calculated on the hour, according to the parameters in Table 9 of the Monthly Parameters Annex, based on the settlement prices of the respective maturities of the United States 10-Year Treasury Note Futures contract truncated in the fourth decimal place.

On the last day of contract negotiation, the settlement price is defined by the first trade made at 11 am in New York or the closest after.

On the day the contract is settled, the value of the last trading day is used.

On dates when there is no adjust price disclosure by CME, the value of the last trading day is used.

6 CRYPTO ASSETS

6.1 Bitcoin Futures (BIT)

The settlement price for the Bitcoin Futures Contract (BIT) is expressed in Brazilian reais per Bitcoin to 2 decimal places

6.1.1 All open expirations

Procedure Sequence to determine the settlement price for a given expiration of the contract

- P1. The settlement price will be calculated using the average price of **valid trades** (see General Provisions section) within the **average calculation window** according to the parameters shown in Table 11 of the *Monthly Parameters Annex* for the afore-mentioned contract.
- P2. If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with valid bid-ask spread, calculated according to the methodology of **VWAP: Volume weighted average price** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 11 of the *Monthly Parameters Annex*.
- P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be defined according to the equation (6.1).

6.1.2 First open expiration on the last trading day

The settlement price for the first BIT expiration is the Nasdaq Bitcoin Settlement Price Index, multiplied by the one-day exchange reference rate of reais to United States Dollars published by B3.

6.2 Ethereum Futures (ETR)

The settlement price for the Ethereum Futures Contract (ETR) is expressed in U.S. dollars per Ether to 2 decimal places.

6.2.1 All open expirations

Procedure Sequence to determine the settlement price for a given expiration of the contract

P1. The settlement price will be calculated using the average price of **valid trades** (see General Provisions section) within the **average calculation window**

according to the parameters shown in Table 11 of the *Monthly Parameters Annex* for the afore-mentioned contract.

If procedure P1 cannot be applied, the settlement price for the expiration in question will be the average price (Mid) of the valid bid and asks offers, with valid bid-ask spread, calculated according to the methodology of **VWAP: Volume weighted average price** (see methodology in the **GENERAL PROVISIONS** chapter at the beginning of this manual) for this maturity, observing the **Quantity Limit** and **Spread Limit** parameters stipulated in Table 11 of the *Monthly Parameters Annex*.
- P3. If procedure P2 cannot be applied, the settlement price for the expiration in question will be defined according to the equation (6.4).

The settlement price for the first ETR expiration is the Nasdaq Ether Reference Price Index – Settlement, multiplied by the one-day exchange reference rate of reais to United States Dollars published by B3.

6.3 Solana Futures (SOL)

The settlement price for the Solana Futures Contract (SOL) is expressed in U.S. dollars per Sol to 2 decimal places.

Procedure Sequence to determine the settlement price for a given expiration of the contract

The settlement price for the first SOL expiration is the Nasdaq Solana Settlement Price Index, multiplied by the one-day exchange reference rate of reais to United States Dollars published by B3.
