Re.: **Processing of B3 Index Portfolios due to the Corporate Reorganization/Partial Spin-off of Viver Incorporadora e Construtora S.A. (VIVR) and RDVC CITY S.A. (CCTY)**

Procedures for the index portfolios

For the opening of the trading session on **April 29, 2025**, the adjustment procedures described below will be adopted, as per the Statement of Material Fact that the companies Viver Incorporadora e Construtora S.A. (VIVR) and RDVC CITY S.A. (CCTY) published on April 9, 2025.

In the Special Corporate Governance Stock Index (IGCX), Novo Mercado Corporate Governance Equity Index (IGNM) and Special Tag-Along Stock Index (ITAG) portfolios, the ordinary share CCTY3 will be included, with a theoretical quantity of VIVR3 multiplied by the exchange factor (0.004), rounding down the result.

In this way, for the IGNM and ITAG indices, the final volume of CCTY3 will be 153,464 shares and for the IGCX index it will be 306,928 shares, in accordance with their methodologies.

Considering the ex-partial spin-off price of VIVR3 and the price set for CCTY3, the total financial value of these assets in the portfolios of the above indices at the beginning of April 29, 2025 will be equivalent to the financial value of VIVR3 at the close on April 28, 2025.

We emphasize that the divisors for all the above indices may be adjusted in the event of corporate actions occurring in other assets that make up the portfolios.

According to Section 5, item C of the BM&FBOVESPA Indices: Concepts and Practices Manual, in the case of a corporate reorganization that occurs when there are fewer than 30 calendar days to the next rebalancing date, the value of the assets involved, as long as they are regularly calculated and available, will continue to be computed in the portfolio up until the following rebalancing, when the normal readjustment procedures will be executed.
