1.1 Listed B3

The following activities will **NOT** take place:

- Trading on the equity, private fixed income, fixed income ETF, listed derivatives and securities lending markets;
- Registration of transactions involving agribusiness securities, except on
 December 29, 2023 (Friday), when registration of trades in agribusiness securities will end at 12:00 noon;
- Contracting, clearing and settlement of transactions and collateral transfers via B3 Clearinghouse, including federal government bond repos and lending with central counterparty (CCP);
- Transfers via B3's Central Equity Securities Depository.

1.2 OTC B3

The following activities will **NOT** take place:

- Trading in federal government bonds;
- Registration of transactions with the Registration Subsystem;
- Transfers via the Centralized Deposit Subsystem;
- Collateral transfers via the CETIP Collateral System;
- Settlement of transactions via the Clearing and Settlement Subsystem.

On December **29, 2023 (Friday),** the OTC B3 system will work shorter hours, closing at **1 p.m.**

1.3 Financing Infrastructure

There will be no change in the business hours of any of these systems.



1.4 Insurconnect

There will be no registration or movement of insurance policies via the Insurconnect system.

1.5 Tesouro Direto

There will be no trading or investment confirmation.

1.6 B3 Foreign Exchange Clearinghouse

There will be no contracting, clearing, collateral transfer or settlement of FX transactions via B3 FX Clearinghouse.

2. Public Holidays in São Paulo

As with the 2022 calendar, the following <u>will</u> take place on 2023 public holidays in São Paulo: (i) trading on the equity, private fixed income, fixed income ETF and listed derivatives markets; (ii) contracting, securities lending markets, clearing and settlement of transactions and collateral transfers via B3 Clearinghouse and B3 Foreign Exchange Clearinghouse; (iii) transfers via B3's Central Equities Depository; (iv) OTC B3; (v) Tesouro Direto government bond trading and settlement and (vi) B3's Financing Infrastructure.

"Observed" in the above table refers to a holiday brought forward because the original date was a Saturday or put back because the original date was a Sunday.

3.1 B3 Clearinghouse and B3 Foreign Exchange Clearinghouse

On US federal bank holidays, the following will apply unless the date is also a national holiday or optional holiday in Brazil:



- B3 Clearinghouse will proceed with the registration, clearing and settlement of all trades, except the settlement of obligations arising from trades in agricultural commodity derivatives, which will take place on the business day immediately subsequent to the date for settlement in New York City, provided this is also a business day in Brasília.
- B3 FX Clearinghouse will only execute trade registration, with the clearing and settlement of all foreign exchange transactions taking place on the business day immediately subsequent to the date for settlement in New York City, provided this is also a business day in Brasília.

3.2 Trading in US Dollar "Casado" Structured Transaction (CSD2)

In order not to affect settlement of T+2 spot dollar transactions, trading in US Dollar "Casado" (CSD2) will be suspended two business days before public holidays in New York, as shown in the table below.

The rules shown in the table below will therefore apply to interbank FX transactions contracted for on the days preceding December 29, 2023.

B3 hereby informs you that on **December 22, 2023** (Ash Wednesday) the hours for trading, registration, clearing, settlement and central depositary activities will be as shown below, with all other provisions of the said Annex remaining in effect and unchanged.

1.1.7 Connectivity testing

Trading in connectivity test instruments will take place between 10:00 a.m. and 12:00 noon. The availability of connectivity test instruments will not change after trading closes.

1.2 OTC B3

No change to electronic trading platform hours.

- For OTC derivatives trades with central counterparty, registration begins at 1:00 p.m.

No change to hours and deadlines for meeting margin calls, collateral transfer, allocation and settlement of transactions in B3 Clearinghouse and B3 FX Clearinghouse, or activities of B3's Central Equities Depository and Registration System.

2.2 OTC B3

No change to hours for activities of Registration Subsystem, Centralized Deposit Subsystem or Clearing and Settlement Subsystem.

3. Tesouro Direto

- Until 11:00 a.m. reception of purchase confirmations (MLTD or boleto jumbo) referring to market on February 17, 2023.
- From 2:00 p.m. market opening.
- From 4:00 p.m. transfer of funds obtained via settlement of sales.
- At 6:00 p.m. close of trading with price recognition
- From 6:15 p.m. on February 22, 2023 to 11:00 p.m. on February 23, 2023
 reception of purchase confirmations (MLTD or *boleto jumbo*) referring to market on February 22, 2023.

4. Hours for registration of Financing Infrastructure transactions

B3 Financing Infrastructure will maintain the usual business hours for all systems.



5. Hours for registration of Insurconnect transactions

The system will be available from **12 noon** for registration and movement of insurance policies.
