Re.: **Update to the List of B3 Products that a U.S. Person may trade, as determined by the U.S. Commodity Futures Trading Commission**

On June 1, 2016, the U.S. Commodity Futures Trading Commission (CFTC) issued a Foreign Board of Trade (FBOT) Registration Order for B3. This allows investors based in the United States of America (U.S. Persons) to continue to have direct access to Listed B3 products authorized by the CFTC, via a Sponsored Direct Connection whose execution solution manager is an authorized investor.

New products are to be added to the list of authorized B3 assets that U.S. Persons may trade as of **May 29, 2023**, namely: Rollover Structured Transactions for U.S. Dollar Currency Futures.

B3 provides several forms of Sponsored Direct Connection, which are described in B3's Trading Procedures Manual and whose infrastructure characteristics are available at www.b3.com.br/en_us/, Regulation, Regulatory Framework, Regulations and manuals, Trading, Access the documents.
