Re.: Review of the Parameters for Trading Tunnels

B3 hereby informs you that as of November 07, 2022, new Equities Market and Futures Market parameters will come into effect for auction tunnels based on fluctuation and on average price; for protection tunnels based on fluctuation and on quantity; and for rejection tunnels, in accordance with the tables below.

The concentration protection tunnel for the Equities and Futures Markets will be deactivated and the protection tunnels based on fluctuation and quantity will remain.

This procedure is a continuation of the quarterly review process of the parameters for trading tunnels, as contained in External Communication 041/2021-VNC.
