This document presents the processes for registration habilitation, platform installation, and technical specifications. We emphasize that this material will be periodically updated by B3.

Registration

The registration structure of the new Fixed Income Trading subsystem utilizes the B3 Integrated Registration System (SINCAD). To participate, the user must be properly registered in SINCAD with an active B3 participant code and have one of the categories listed below enabled:

1. Bank:

• PBAL (B3 OTC Participant): Mandatory registration category for Treasuries that operate directly on the platform.

• **GEST (B3 OTC Manager):** Optional registration category for Treasuries that need to operate on behalf of their proprietary funds.

2. Brokerages:

• PBAL (B3 OTC Participant): Mandatory registration category for brokerages that operate directly on the platform.

• **GEST (B3 OTC Manager):** Optional registration category for brokerages that need to operate on behalf of funds under their management.

• **PN (Trading Participant):** Mandatory registration category for brokerages that operate directly on the platform.

• **PNP (Full Trading Participant):** Mandatory registration category for brokerages that wish to conduct automated paired operations directly on the platform, for their own position and for third parties (intermediation).

3. BuySide:

• GEST (B3 OTC Manager): Mandatory registration category for Managers, Administrators, Funds, Foundations, Insurance Companies, and Investment Clubs that need to operate directly on the platform. 4. Non-Financial Legal Entities:

• Viewers: This is an optional access category intended for non-financial legal entities that need to view public offers on the platform. This category does not allow management in the B3 Unified Registration System (Sincad) and grants permission for consultation only. Access will be carried out exclusively via the web page.

For institutions not registered in Sincad, the procedure for creating accounts must be initiated through B3's registration support, using the following channels:

Access Management

The access management of the new trading subsystem is carried out through the B3 Unified Access Control System (CAU). In this system, the privileged user of the institution is responsible for creating and maintaining the common users of the platform.

For current users of the Trader Platform (one-time procedure):

• Institutions that are active on the Trader platform and have made at least one access in the last six months will have their users automatically included in the new subsystem in the production environment. For those who are already registered in the B3 CAU, the login will remain the same and will also be valid for accessing the new Fixed Income trading environment of B3. For users without CAU registration, the system will automatically send access credentials (login and temporary password) via email.

• After this initial load, the responsibility for managing existing and new accesses will rest with the privileged user of the institution registered in the CAU.

For privileged users of institutions that wish to anticipate or test access and interaction with the B3 Unified Access Control System, a guide is provided to perform the access procedure and include common users.

The download is available for all users registered on the platform via the Unified Access Control of B3 (CAU). It is recommended to seek support from the institution's technology team for the installation.

Participants who use the internet connection format for the platform must select this option on the system's login screen. After logging in through this channel, a token for the second authentication will be requested, which will be sent via email.
