Re.: **B3 Market Data – Provision of New Form of Data Display**

B3 hereby informs you of a new form of data display, namely the “Real time display of BOVESPA segment data at platforms and websites”. This new service becomes fully part of the B3 Market Data Commercial Policy as of the publication of this External Communication.

Upon contracting, the new service will allow B3 Market Data distributors and redistributors the real time display of the following BOVESPA segment data at websites and platforms:

- last transaction price, with date, hour, minute and second
- reference price for illiquid instruments
- the asset’s price variation and financial volume

B3 reserves the right of prior assessment of every request to contract the new service, and of the type of website/platform at which the above data will be provided.

Users of this new service will not have to provide a monthly report, but the distributor or redistributor will be responsible for the upkeep of auditable

evidence of the total number of end users.

For distributors and redistributors to be able to assess the new service, B3 will offer exemption from costs in the first month after contracting. After this period, costs will be charged as normal.

This new service is contracted by sending an updated version of Annex II of the B3 Data Distribution Agreement.
