Change to the rules for monitoring market maker obligations

Summary: As of August 1, 2025, this Circular Letter revokes and fully substitutes Circular Letter 084/2023-PRE, dated May 30, 2023.

B3 informs you that as of **August 1, 2025**, this Circular Letter fully revokes Circular Letter 084/2023-PRE dated May 30, 2023, **so that the section "Maximum number of parameter breaches" will cease to be effective** for all of the market maker programs in effect. listed in Annex 1 hereto.
