

Business Continuity Plan Test of the PUMA Trading System Electronic Platform

Destined for segment participants: Listed.

Summary: The test will be held on November 13, 2025 (Thursday).

As informed in External Communication 005/2025-VNC, dated February 6, 2025, B3 will hold a Business Continuity Plan validation test of the PUMA Trading System electronic platform (PCO-PUMA) on November 13, 2025 (Thursday).

B3 developed PCO-PUMA to allow positions, and the risk stemming from them, to be reduced. It uses alternative mechanisms for executing and sending trades to post-trade when the PUMA Trading System becomes unavailable at the primary and secondary data processing centers during the trading session and cannot be restored on the same day.

The brokerage houses authorized to trade at Listed B3 must participate in at least two PCO-PUMA test validations during the year, as set forth in External Communication 005/2025-VNC, dated February 6, 2025.

Full trading participants will access PCO-PUMA through their internet link, using the address <https://pcopuma.b3.com.br:8197/#/login>, entering the same login and password used by supervising traders to access ePUMA, as described in the document PCO-PUMA – Participant Guide, which is available on the B3 Extranet.

1. Mock trading session timetable

Starts	Ends	Phase
6:30 p.m.	7:00 p.m	Login to the application and the entering of cross orders, matched trades, bids and asks.
7:00 p.m	7:30 p.m.	B3 processes data.

2. Scope of the mock trading session

The mock trading session will cover the following:

- Access to <https://pcopuma.b3.com.br:8197/#/login>;
- Entry of cross orders, as described in the validation script;
- Entry of matched trades, as described in the validation script;
- Entry of bids and asks, as described in the validation script;
- Receipt of alert messages; and
- Interaction with B3 as counterparty or to facilitate execution of the specific mock trading scenario desired by the participant.

The mock trading contingency session will **not** cover:

- Use of post-trade, settlement and risk systems or clearinghouse margin and collateral management systems;
- Production and delivery of PCO-PUMA validation test reports and files; and

Orders entered via PUMA Trading System.

3. Other information

Participation in the mock trading session must be confirmed no later than **12 noon on Wednesday, November 12, 2025**, by sending an email to suporteanegociacao@b3.com.br with “PCO-PUMA test” in the subject line, and a message identifying the institution, naming the individuals who will participate and supplying their contact details (telephone numbers and email addresses). In response to this confirmation, the participant will receive the mandatory test script with the activities that will be performed during the test.
