RECTIFICATION

This document refers to Circular Letter 040-2025-VNC, dated October 14, 2025.

New trading hours

Destined for segment participants: Listed.

Summary: See the new trading hours in effect.

This Circular Letter revokes and substitutes Circular Letter 040/2025-VNC, dated October 14, 2025, regarding the new trading hours in effect as of November 3, 2025. Below we have published the rectified information.

The settlement price determination window for the S&P 500 futures contract (ISP) will be from 5:59 p.m. to 6:00 p.m. and the trading hours for the Micro Bovespa B3 BR+ Index Futures Contract (IBBR B3) will have an electronic closing call starting at 6:25 p.m., as set out in Annex 1.

Furthermore, the hours for the receipt of the positions file plus IMBARQ for equity index options and the hours for automatic exercise of the holder's position will be, respectively, at 6:15 p.m. and as of 6:20 p.m., as set out in Annex 3.

The other information regarding the trading hours remains unchanged.

Due to the end of daylight-saving time in the United States on **November 2, 2025** (Sunday) and in Germany and the UK (London) on **October 26, 2025** (Sunday), the trading hours of the exchange market and organized OTC market that B3 operates will change.



The new timetables will come into effect as of **November 3, 2025** (Monday) and **October 27, 2025** (Monday), respectively, as described in the annexes hereto:

- Annex 1 Timetable effective as of **November 3, 2025**, for the derivatives market.
- Annex 2 Timetable effective as of November 3, 2025, for the equity market, except options exercise.
- Annex 3 Timetable effective as of **November 3, 2025**, for equity options exercise.
- Annex 4 Timetable effective as of October 27, 2025, for Structured Transactions –
 Forward Points on Mini U.S. Dollar Futures Based on the WMR FX Benchmarks
 USDL/BRL Rate (FRW), and for Dax Futures (DAX) and Euro Stoxx 50 Futures (ESX).

In the timetables given in Annexes 1 and 2 **there will be no change** to the current trading hours for the structured transaction Forward Points on US Dollar Futures with positions opened on TO (FUT FRPO); and **there will be no** after-market sessions in the equity market, <u>except</u> on the options expiration date specified in Annex 3.

The Price Report (BVBG.086) and Index Bulletin (BVBG.087) files will be published at the approximate times shown below, except for the last publication of the BVBG.086 file and the publication of the Simplified Price Reports (BVBG.186 and BVBG.187) on the expiration date for options on single stocks, units and ETF shares, which will occur at approximately 8:15 p.m.
