As part of the preparations to launch block trading products and facilities and seeking to assist the planning of participants, vendors and customers, B3 hereby informs you that it is creating a domain for block trade market identification.

We are creating this domain to complement the recent updates mentioned in External Communication 166/2022-VNC, regarding the creation of a new instrument for trading in Midpoint orders, characterized by the letter M, and new domains in the SecuritySubType field for the three facilities.

These changes and the block trading facilities are still pending the approval of the regulatory bodies.
