2. INTRODUCTION

This **Market Data B3 Commercial Policy** shall be read in conjunction with the **Market Data B3 Consumption Policy** and the **Periodical Self-Report Submission Manual**. Capitalized terms not otherwise defined herein shall have the meanings assigned to them in the **Market Data B3 Consumption Policy**.

This document lists the **Market Data B3** products available for licensing and their pricing policy.

The fees listed in this **Market Data B3 Commercial Policy** apply per **User**, per counting unit, per month, per **Dataset**, unless otherwise indicated, and are invoiced monthly in arrears.

If the **Distributor**, **Redistributor**, or **Reporting User** submits a correction to an already submitted **Periodical Self-Report**, any applicable payment adjustments shall be made based on the prices in effect in the month of correction, without applying any discounts that may have been applicable at the time of the original report or in the month of correction.

2.1. National Licenses and Applications

The fees related to **Licenses** and **Consumption Applications** consumed by **National Licensees** are expressed in Brazilian Reais (BRL).

The BRL tariffs contained in this **Market Data B3 Commercial Policy** will be subject to monetary adjustment, being adjusted annually, as of January 1 of each year, by the Extended National Consumer Price Index (IPCA) accumulated in the twelve (12) months accumulated until June of the year prior to the effective date (therefore, from July to June).

In the event of extinction, discontinuity or unavailability of the IPCA, another official index will be adopted as a substitute index to replace it, according to the criteria defined by the Central Bank of Brazil or competent authority.

2.2. International Licenses and Applications

The fees related to **Licenses** and **Consumption Applications** consumed by **International Licensees** are expressed in US Dollars (USD).

Fees in USD will be converted to BRL using the reference exchange rate calculated daily by the Central Bank of Brazil – PTAX Venda ("PTAX") valid for the last day of the month of use of the Data contained in Market Data B3.

If the **Distributor**, **Redistributor**, or **Reporting User** submits a correction to an already submitted **Periodical Self-Report**, any applicable payment adjustments shall be made based on the **PTAX** rate applicable to the month in which the correction is submitted, and not the conversion rate of the month of data usage.

The tariffs in USD contained in this **Market Data B3 Commercial Policy** will be subject to monetary adjustment, being adjusted annually, effective as of January 1 of each year, by the *Consumer Price Index* ("CPI") accumulated in the 12 (twelve) months accumulated until June of the year prior to the year in force (therefore, from July to June).

In the event of extinction, discontinuance or unavailability of the **CPI**, another official index will be adopted as a substitute index to replace it, according to the criteria defined by **B3**, observing the principles of good faith.

2.3. Non-Display Applications with Enterprise Purpose

When electing to report the **Non-Display Enterprise Fee for Trading Applications** and **Non-Trading Applications**, the **Reporting User** will only inform this option and should not report the **Trading Applications** and **Non-Trading Applications** of the same **Location** individually.

In this case, each **Location** where the **Non-Display Application** of a given *Dataset* is consumed should be reported as an individual **Enterprise**.

2.4. Changes to the Market Data B3 Commercial Policy

In addition to the correction of prices by inflation indexes, **B3** reserves the right to change the rates contained in this **Market Data B3 Commercial Policy** at any time, at its sole discretion and upon prior notice, respecting the terms and conditions established in the **Market Data B3 Consumption Policy**.

Any price change will be disclosed by updating this **Market Data B3 Commercial Policy**.

B3, at its sole discretion, may grant discounts and exemptions.

3. REPORTING PROCEDURE

Without prejudice to the rules established in the **Market Data B3 Consumption Policy** and the **Periodical Self-Report Submission Manual**, it is worth mentioning:

3.1. Consumption, Reporting and Billing Cycle of Market Data B3

The consumption of the **Data Contained in Market Data B3** is calculated monthly and reported in arrears through the submission of the **Periodical Self-Report** during the reporting period, which begins on the 1st day and ends on the 15th day of the month following the month of consumption, or on the next business day if the 15th day is not a business day.

B3 processes the **Periodical Self-Report** submitted during the reporting period in accordance with the tables and rules in effect under this **Market Data B3 Commercial Policy**, for purposes of calculating the fees due for **Licenses** and **Consumption Applications**, as well as any fines, penalties, and adjustments, including those arising from corrections to **Periodical Self-Reports** made by the **User** before the end of the current reporting period.

Invoices referring to reported consumption will be issued by **B3** with maturity, as a rule, on the 15th (fifteenth) day of the second month following the month of consumption or the next business day when this date is not a business day.

Example:

The **Data contained in Market Data B3** consumed by the **User** during the month of January will be reported by him in the reporting period that runs from February 1st to 15th. **B3** processes the information reported by calculating the amount owed by the **User** and issues an invoice due on March 15.

3.2. How to submit the Periodical Self-Report

Distributors, Redistributors, Managed Service Providers (PSGs), and Reporting Users must submit the **Periodical Self-Report**, for themselves and for the institutions listed in their **Reporting Group**, in accordance with the definitions and obligations set forth in the **Market Data B3 Consumption Policy** and in the **Periodical Self-Report Submission Manual**.

For further information on how to submit the **Periodical Self-Report** from the effective date of the **Market Data B3 Consumption Policy** and this **Market Data B3 Commercial Policy**, the reporting party should consult the **Periodical Self-Report Submission Manual**.

3.3. Reporting of Operations Professionals Applications

The **Operations Professional**, as defined in the **Market Data B3 Consumption Policy**, is the individual necessarily linked to **B3's Participants** who have **Licenses** contracted with **B3**, and uses the **Operations Professional Terminal** exclusively to perform the function of desk operator or financial advisor in the intermediation of capital market operations.

To be *entitled* to the differentiated price, this **B3's Participant** holding a **License for Internal Use or Distribution** must:

- a) If the **Operations Professional Terminal** is its own technological solution, report it in its **Periodical Self-Report for Internal Use**, linking the document of the **Operations Professional** who uses the **Consumption Applications** in the **Periodical Self-Report**;
- b) If the **B3's Participant** is a sponsor of a **Trading Professional Terminal** offered by a third party, it must request this third-party holder of a **Distribution License** to report this **Trading Professional Terminal** in its **Periodical Self-Report**, necessarily linking it to the **B3's Participants** as the sponsor of the **Consumption Application**; and
- c) In all cases, keep the registration of this **Operations Professional** updated in the database indicated in the **Periodical Self-Report Submission Manual**.

Failure to comply with any of these requirements will lead to the conversion of this **Consumption Application** from an **Operations Professional Terminal** to a **Professional Terminal** by **B3**, and this fee will be applied in the calculation of the amount due.

3.4. Report of Technology Professionals Applications

The **Technology Professional**, as defined in the **Market Data B3 Consumption Policy**, is the individual necessarily hired by an institution that holds an **Internal Use** or **Real-Time Data Distribution License**, regardless of whether it uses its own

or third-party technology solution, which uses **Market Data B3** via **Professional Terminal** exclusively to (i) develop and test systems (software and hardware), and (ii) provide technical support and technical assistance, being prohibited to act in activities related to trading, such as, but not limited to, the design, modeling, development and maintenance of algorithms, the sending of orders, as well as recommendations, elaboration of strategies or trading ideas for your institution or for clients.

To be *entitled* to the differentiated price, this holder of an **Internal Use** or **Distribution License** must:

- a) Regardless of whether the **Technology Professional Terminal** is your own technological solution or that of a third party, report it in your **Periodical Self-Report for Internal Use**, linking the document of the **Technology Professional** who uses the **Consumption Applications** in the **Periodical Self-Report**, as many times as there are technological solutions used by this **Technology Professional**, pointing out the solution provider in the **ID/Platform** field; and
- b) If you are a sponsor of a **Technology Professional Terminal** offered by a third party, you must also request this third-party holder of a **Distribution License** to report this **Technology Professional Terminal** in its **Periodical Self-Report**, necessarily linking you to the **License** holder as a sponsor of the **Consumption Application**.

If any of these requirements are not met, **B3** will convert this **Consumption Application** from a **Technology Professional Terminal** to a **Professional Terminal**, and this fee will be applied in the calculation of the amount due.

If the indicated **Technology Professional** appears as an **Operations Professional** in the database indicated in the **Periodical Self-Report Submission Manual**, **B3** will convert this **Consumption Application** from a **Technology Professional Terminal** to an **Operations Professional Terminal**.

The report mentioned in item "b" above does not generate a charge to the third party.

B3 will charge only once per **Dataset** each indicated **Technology Professional**, regardless of the number of technological solutions used by him/her, and the sum

of these Consumption Applications will be limited to the amount defined in the price list.
