1 INTRODUCTION

This glossary is a document that represents the terms, codes and definitions applicable to the data service files provided by B3.

The following list contains definitions for the file TradeInformationConsolidated (Consolidated Trades – Regular Session).

The order of the fields respects the sequence in which the columns of the file are.

2 DATA DESCRIPTION

The file TradeInformationConsolidated_YYYMMDD, informs the statistics of the trades consolidated by assets, carried out during the current regular session, bringing the transparency of the trades carried out in the regular session to the market.

The dissemination of the current data is carried out every day at night.

The file available is a zipped folder containing a .csv in the format shown in the table below.
